Treasurers' Report – Rich Lankford – no major outstanding expenses. Club is in the black.

Old Business – Phil Wehman gave a report on the Street Survival at Hamilton Southeastern High School. Phil's suggestion is that the involvement that Indy Region has with Street Survival is as a sponsor – leave the organization to the BMW Club in the area. Phil was impressed with the organization and content of the program and recommends it to anyone with children that are just starting to drive.

A reminder from Steve Linn that the 2009 elections for the Indy Region BOD will be taking place soon. So far he has received 1 ballot. Steve will not be the R.E. for 2009. Region Officer Job Descriptions

To help us recruit new leaders, we present the following Job Descriptions for Region Officers. This list is by no means comprehensive, but is offered as a guide during the upcoming elections.

Regional Executive

- Chief Executive Officer of the Region.
- Official Spokesperson for the Region.
- Presides at all meetings of Members and Directors.
- Shall report on the status of the Region at each meeting.
- Shall call any special meeting of Members and Directors in accordance with the Bylaws of the Region.
- Prepares and adheres to agendas for all meetings.
- Shall appoint or discharge necessary and appropriate positions and committees.
- Shall sign and execute, together with the Treasurer (or his assignee), all contracts, notes, and drafts in the name of the Region.
- With the Treasurer, participate in creating and assist to determine the Region's budget for the coming year.
- Shall perform or cause to be performed all duties assigned to him/her by the Sports Car Club of America, Inc.
- Shall cause books, statements, reports and other certificates and records to be filed as required by law.
- Shall complete (with aid of Assistant RE) Region SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Shall complete SCCA Directory information for the Region and submit to the National Office no later than December 31st of each year.
- Shall enforce Region's Bylaws and perform all duties incidental to the office of Regional Executive.
- Shall supervise all activities of the Region.
- Shall have other such duties and authorities as prescribed by Bylaws or Regions Board of Directors.
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Communicate as needed with Executive Officers of other local sports car clubs, SCCA Regions, and SCCA Divisions.
- Shall maintain communications with the responsible SCCA Area Director.

Assistant Regional Executive

- Performs duties of the Regional Executive in that person's absence or incapacity.
- Performs other such duties as assigned by the Regional Executive.
- Performs duties as assigned by the Region's Board of Directors.
- Shall attend all meetings of the Members and Directors.
- With the Regional Executive, shall prepare the Region's SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.

Secretary

- Shall keep minutes of meetings of Members and Directors.
- Shall be the custodian of all records of the Region.
- Shall attend all meetings of the Members and Directors.
- Work closely with the RE and Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Shall maintain the Region's calendar of events.
- Shall submit the Region's calendar to newsletter and website.

Treasurer

- Shall have care and custody of, and be responsible for all funds, merchandise, and assets of the Region.
- Shall have custody of monies, debts, and financial obligations of the Region.
- Shall attend all meetings of the Members and Directors.
- Reports financial status of Region to Members and Directors.
- Shall maintain accounting records in accordance with Generally Accepted Accounting Principles.

- Pays listing or sanctioning fees in advance of any SCCA event.
- Shall transmit dues and income information received from the SCCA National office to the Region's Membership Chairperson.
- Shall make monthly, or more often if required, deposits to the Region's bank account.
- Obtain tax exemption certificate if required.
- With the Regional Executive, participate in creating and assist to determine the Region's budget for the coming year.
- Work closely with the RE and the Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Shall ensure preparation and filing of tax returns in accordance with the Internal Revenue Code of the United States and other controlling jurisdictions.
- Shall notify the Region's bank(s) when changes are made with respect to addresses, signatures, and other contact information for new officers or check signers.

Membership Chairperson

- The Membership Chairperson promotes continued growth of the Region through actively recruiting new Members and retaining current Members.
- Shall be the Chairperson of the Membership Committee.
- Shall make new Members and other interested parties feel welcome at all Region events.
- Shall maintain a list of Members and other interested parties. The list shall include all available contact information.
- Shall prepare an annual Region roster.

Other Directors or Officers

- Shall attend all meetings of the Members and Directors.
- Shall perform such duties and have such powers as assigned by the Board of Directors
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc. May be assigned as liaison to committees and specialty chiefs who are not already members of the Region's Board of Directors.

Elections for the 2009 Indianapolis Region Board of Directors will be held on Saturday, January 17, 2009 at the Annual Membership Meeting/Awards Banquet. If you have additional questions, please feel free to contact any of the current members of the Board of Directors. Contact information is on the inside front cover of the newsletter.

In addition, there are other non-elected positions of importance for the club, described below. Often, these people have also been appointed Directors each year.

Newsletter Editor

- The newsletter editor generates a periodical publication and distributes it to all Region Members and other interested parties.
- Shall produce a publication that is professional appearing and easy to read.
- Generates content that is relevant to the Region and SCCA activities.
- In cooperation with the Region's Secretary, shall generate a calendar of events.
- Shall include reports of all the Region's events.
- Shall work closely with the Region's Webmaster to ensure accuracy and timeliness of shared information and stories.
- Shall secure advertising to offset publication costs.

Webmaster

- The Region's Webmaster designs the webpage and maintains content that is relevant to the Region and SCCA activities.
- Maintains a professional and easily navigated site.
- Ensures that the website is updated on a regular basis and is timely.
- Collect stories, features, and pictures for web content.
- Works closely with the Region's newsletter editor to ensure accuracy and timeliness of shared information and stories.
- In cooperation with the Region's Secretary, shall generate a calendar of events.
- Shall include results from all of the Region's events.

Current Great Lakes Division Representative and SCCA Director Larry Dent Has decided not to continue in this capacity for Health and Personal reasons. Great Lakes Division members have the opportunity to vote for their new Director on the SCCA Board of Directors. Platform Statement of John LaRue

Candidate for SCCA Area 4 Director

Dear Great Lakes, Area 4 Member:

As you may be aware, I am seeking to become your representative on the SCCA Board of Directors. I am doing so at the urging of a number of racers and existing members of the Board who are struggling to make positive changes for the Club against a tide of "good old boy" favoritism and power brokering. They, as I, am tired of poor decision making which is bringing the club to its knees.

I will not lay out a lengthy resume' of accomplishments, but will simply point out that I have been active in racing since the age of twelve (12) years. I have managed and promoted racing events and racetracks; I have owned and operated motor sport related manufacturing businesses and have been involved as a car owner, mechanic and driver in regional and national SCCA club racing for about 15 years. In that regard I have been fortunate to realize success participating in major SCCA events. I am an attorney by profession and provide legal counsel to the motor sport industry and several sanctioning bodies.

I do not seek this position for the glory of being a member of the Board nor do I need additional work to keep me occupied. I simply seek this position to make a positive change, to set the club on the right track and to help ensure its' future. I will briefly note my thoughts and concerns:

First, we must, as a club realize that the environment has changed. There is ever increasing competition for the disposable income of our members not to mention their spare time. Unless and until the club produces events and programs that offer good value and entertainment it will continue to see participation decrease. While we can certainly point to fuel costs and the economy over the past 24 months, this does not give us an excuse for the decline that proceeded that period. Simply stated we cannot afford to operate our club as we have in the past. While I am a big proponent of tradition, there is a point where we have to realize that what worked yesterday for our members will not work today. In this regard the BOD must determine what the membership needs to increase participation. The BOD must not only hear what the membership tells it, it must listen and react. All too often good ideas simply fall on deaf ears. As a member of the BOD I will listen to anyone who wishes to call, email or otherwise sit down and discuss matters. I am open to good ideas and realize that the solution to the problem lies within the membership not with some outside consultants who will "market" our club. We already have a good membership base; we simply need to energize them to participate!

Generally speaking I believe that the Club needs to focus on making events more desirable to attend by

- 1) increasing the number of participants per class
- 2) increasing track time per event
- 3) decreasing the "hassle" factor of attending
- 4) decreasing the cost of attending.

There are a multitude of ideas to accomplish these ends that have been discussed in bench racing sessions and across the various internet forums. I am most certain that each of you have at least one or two ideas that would make you more likely to attend more events and what would make those events more enjoyable. Not only must the BOD listen to the members, it must ACT upon their requests, opinions and ideas! They must remember that the members are the most valuable asset of the Club.

One of the most disturbing issues locally is the current state of the Division. The split of the Division has taken us from the largest most prosperous Division in SCCA to one which is struggling to make minimum participation numbers. While I was not involved in this action, I did speak out against it and believe that it is vital to re-unify the Divisions. Simply stated, the reasons behind the split do not justify the harm it has caused. If elected I will work relentlessly to re-unify the Division and rejuvenate its health.

Another disturbing issue is our loss of venues and the absence of new venues. Solo, Rally and Road Racing all need to continually work to seek out new venues and enhance the relationship which we have with existing venues. Comments that the owners of the facilities do not "get along" with SCCA is simply not acceptable. We must get busy and rectify these broken relationships and develop new. To this end we need to appoint a full time person at the national level to act as the chief liaison as between the club and these facilities with a primary objective of securing new venues and facilities for SCCA activities.

There are many other issues which have my concern and cause me to seek this position. These include but are not limited to poor business and management decisions which seemingly bring forth a constant stream of potential legal liabilities for the club. Given the nature of this letter I will not get into further detail here, but will be most happy to discuss any issues or ideas that you might have. Platform Statement of Marcus Merideth

Candidate for SCCA Area 4 Director

My experience with many levels of the club as a competitor, crew and volunteer provides me with a broad based perspective of how the Club operates and how to address the issues facing it today.

The Great Lakes Division National Racing program is at a cross roads. Declining numbers of participants and volunteers threaten the viability of events. Scheduling conflicts have driven us to a competitive situation between Regions and Divisions for participants and volunteers to the detriment of all. Continuing to address the situation with the same old approach has not worked and will not work. A fresh perspective on the National level is needed. Exciting and fun racing drives the club and is what attracts participants and volunteers. Analyzing event scheduling from a National perspective will eliminate event deterioration and help all Regions get their share of the pie. Possible solutions are to have fewer events, restrict the classes at the current events so the competitors have fewer events, or have weekends showcasing classes offering more seat time or a preferred race time. Finding a way to include a PDX in a race weekend might be a way to offset some of the event costs. I am sure there are more ideas out there but continuing on the current path is not the better idea. Working together on the Regional level, we must find a solution and move forward.

This is a very exciting time in the SCCA. Challenged by a slow economy and real competition in the market, we need to solidify our position as the leader and the best place to have fun while playing with cars. SCCA was once the place to go for motorsports competition in the US. Now there are numerous competitors trying to wrestle the crown away from SCCA. We have been letting them win recently. As a Club we need to promote ourselves both nationally and locally. Reaching out in the community with driver training and other community service activities will show our enthusiasm and value. Formula SAE is a great program for SCCA and we must do everything we can to provide the competitors and organizers a positive experience. Mentoring the local collegiate team and encouraging them to come out and play with us not only at Solo events but all events will guarantee the future of SCCA. SCCA continues to be the safety leader in motorsports and that must continue. We must reinforce our strengths and address our weaknesses. SCCA will be known as the best events with the best competition in the US.

SCCA is a club and a business. Fiscal responsibility and openness will allow us to maximize the membership value.

Financials should be tracked on a quarterly not yearly basis. Action cannot be taken at the end of the year to offset unexpected occurrences. Fiduciary responsibility for the SCCA is the BOD's primary responsibility and along with that communicating to the membership. We must assure we never see financial difficulties again with long term planning and commitments.

My experience with the Solo Events Board and working with the BOD leads me to believe that one thing we are not lacking is passionate knowledgeable people who want the Club to be the top of the motorsports pyramid. When the Club needs advice or help, we should not be afraid to ask the membership for that help or advice. The BOD should be setting direction and policies not running the programs. I bring both competitor and administrator experience to the Board.

Continuing on along the current path will not lead SCCA to the future. The current BOD is highly biased to road racing and continuing the status quo. My extensive competition history and broad based volunteer experience make me uniquely qualified to lead the Great Lakes Division as their member on the Board of Directors.

Steve Harris' Area 4 Condensed Election Platform

Thank you for your interest in this year's Area 4 election. It is a critical time for SCCA. We have real competition that has directly targeted us. We are getting older. Our products are getting stale. We must take immediate action to meet today's challenges. New leadership is required that understands what we do well and has the intelligence and courage to fix our problems and move us forward. More importantly, we are only electing 1 of 13 Directors. Our Director must know how to motivate and work with others to execute a plan to reach our goals. I am the best candidate for the job. Please con-

sider my Platform and the steps we will use to return SCCA to its position as the premier club for autosports enthusiasts.

GENERAL I seek to represent you. I will actively solicit your thoughts on how to improve our club. Communication is the key. I will communicate with you monthly via the Great Lakes Website and through email releases to all Regional newsletters and to any individual who wishes to sign-up on a Director's Distribution list. But I am also here to listen to your ideas/concerns/problems. Your emails will be answered.

2. We will improve the SCCA by making it fiscally sound. We will promote our sponsors and create events that potential new members will want to join. And we will apply smart business principles that help reduce our member's individual costs.

BOD and OPERATIONAL REFORM We are very fortunate to have an excellent staff at SCCA. They need better direction from our BOD. The BOD should be trained to understand their role. I would employ professional services for that purpose.

2. Our Risk Manager and Legal Counsel is currently the same person, which is a potential conflict of interest. These jobs should be separated. With 20% of our operating budget in insurance costs, it is logical to devote more resource to reducing these costs.

RULES AND THE GCR Rules should be frozen so there are no mid-year rules changes.

2. The Competition Review Board (CRB) does a competent job, but can be improved by having each class represented by an entrant or driver in that class.
3. I would ask the CRB to simplify our rules so that races can be run with fewer race officials, competitors can police themselves, and the race officials would be more pro-active to assist competitors.

THE RUNOFFS The Runoffs™ have lost their luster because it is too easy for slow, poorly prepared cars to qualify. I would propose to the Club Racing Department that the top three cars (by points) in each Division get a free entry to the Runoffs™; the top five cars receive tow money and the top seven cars get invited. The result will be National Championship Races that are meaningful as racers compete all season for the free slots, tow funds and invitations.

2. Every National class deserves their own race at the Runoffs™. But we must cap the number of National classes at 24. This is a CRB function; not a BOD function. If we have a CRB where each individual represents a class, then the specific CRB members can meet and decide how to equalize performance of joined classes.
3. I am against making any IT class into a National Class. IT is grassroots, relatively low buck racing and should be enjoyed by those desiring this product. Making this a National Class would create \$100,000 IT cars much like in AS, and ruin the flavor of this class.

MOVING THE SCCA FORWARD Increasing membership has always been a goal of SCCA. I believe that a better goal would be to improve member equity by delivering better products. Increased participation (memberships) will come if we are successful building the brand. It equates to generating more sources of revenue, increased membership and lower costs for our activities. Here is how we build the brand:

1. SCCA Enterprises should be a key component in building the brand. I have already detailed a plan with Erik Skirmants, President of SCCA Enterprises and we believe it is a great method or recruiting new members into SCCA and generating increased revenues for the club.
2. SCCA University can build the brand. It can be used to train our volunteers, insure and certify them. Certified volunteers should reduce our insurance costs, build respect for our specialties and make them a valuable asset to other sanctioning bodies.
3. Really hip jackets, shirts and shoes build the brand. SCCA can be branded to appeal to youth, which then brings them into the club.
4. The Street Survival Program should be expanded. This program focuses on young driver training. In 2008 we will do 28-30 such schools. The momentum of these programs should be capitalized by creating affiliated High School chapters of SCCA. This builds the brand with the youth market. We could

be a force for High School affiliated driver training. The public exposure and PR are invaluable.

5. Media exposure builds the brand. Product placement through movies or a movie based around the Runoff™ would be ideal. Look what "The Fast and the Furious" did for the car tuner industry. My own company has had placements with movies like *Jurassic Park* and *12 Monkeys*. It is not that difficult to interface with Hollywood.
6. Contract with a gaming company to create a video game based upon the SCCA Runoffs™, RallyCross or Solo Nationals. This also enhances our value with sponsors who want their name associated within the game. But more importantly, it teaches the pattern for young people how to compete within SCCA.
7. Publicity and Sponsorships require coordinated expertise. We need a full time staff position dedicated to this important function for club racing, solo and rally, with a portion of the revenue generated from this effort allocated to the Regions so that the sponsorships are meaningful and enforced across the entire club.

BUILDING MEMBER EQUITY – OWNING THE PLAYGROUND

I will work to establish an SCCA owned/invested track within Great Lakes Division. The SCCA owned/invested track will include a Solo site.

REDUCING MEMBER COSTS The cost of membership is too high. It is an impediment to recruiting new members and retaining older members. I would propose a dues reduction of 25% within three years and 50% over five years. This is enough time to launch our other programs and offset these reductions.

2. It is also too expensive for many of our members to attend the National Convention. I will work to develop sponsors that specifically support the National Convention with the goal of reducing these costs.

Chairman of the Boonshoft Museum of Discovery Concourse d' Elegance for 10 years, an event supported by WOR-SCCA and over 100 volunteers. Member, Board of Trustees – Dayton Museum of Natural History Member, Board of Trustees – Boonshoft Museum of Discovery

Advisory Boards – Cedarville University, Sinclair Community College, National Association of Industrial Technology (NAIT), Robotics Industries Association (RIA), BEST Robotics, Executive Steward – Central Division and Great Lakes Division 2004 – present; Responsible for 4 Spring Training Meetings & 2 Roundtables.

Authored many new training materials for the Stewards Program that have been used nationally. Authored the Steward Strategic Plan for the National Stewards Program and presented it at the 2008 National Convention. Although provided a budget by Great Lakes Division, I have never used that budget or charged the Division for any of my expenses.

Indianapolis Region was represented at the 2008 Runoffs by 9 drivers in 7 classes. As the cover tells, Jason Knuteson obviously had a great week, culminating with the winning of the Formula 500 Race from the Pole Position, and was the only Podium finisher for Indy Region this year. Let's review the races in the order they ran.

Shortly after I arrived mid-day Monday, I saw a familiar looking Black T2 car with number 98 on the side; but wait - it's not Bill Batens Camaro!! I found Bill in the paddock, along with his less than 1 week old Pontiac Solstice. Seems the Camaro just isn't competitive any more, so Bill switched. And even though the Monday session was the first time in the car, and the first time for the car on the track, Bill managed 4th fastest time in qualifying. The time



held up for the week, and Bill was gridded 4th for the first race on Friday morning. On the first lap, Bill had some problems and was held up, falling back to 6th place, but kept with it and held on for 6th at the flag. A good showing for a brand new car in a very competitive class at the National Championships.

The second race had Paul Holeman in his Formula Mazda. Paul managed a 14th Qualifying position, and stayed steady through the race to finish 12th.



The last race on Friday was for Grand Touring 2, and Gerry Mason worked hard in the qualifying sessions to get into 4th place on the grid. Unfortunately, a first lap problem put Gerry out of the race, pulling into the pits at the end of the lap and finished for the day.



Saturday came in bright and cheery, and racing started as planned. The 4th race in the morning (Race 13), last before lunch break, was for Formula 500, and Jason Knuteson was ready for all comers, qualifying on the pole for the third year in a row. Jason got a great start, drove hard in front of a very strong field, never set a tire wrong for the whole race, and brought his Scorpion to the checkered flag for his first National Championship. Former Indy Region member (and former F500 National



Champion) Aaron Ellis worked his way up from 9th qualifying to take second place under the flag. Also in this race was James Weida, qualifying his Scorpion in 14th place on the grid. James was holding his own for the first 4 laps, but mechanical problems put him out of the race.



Race 16 on Saturday afternoon had two Indy Region members competing in their Formula Fords. Team Effort teammates Brad Hayes and Michael Baden qualified 14th and 17th respectively, still within 4 seconds of the pole time. In the race, Michael kept pace with the



others around him, finishing 18th, while Brad was able to pick his way through some competitors to get to 10th at the end of the race. This was the first Runoffs appearance for both drivers, and they showed they can race with the best in the country.



The next race was for Grand Touring Lite, and Bill Partridge had his trusty old Nissan Sentra in the race. The restrictions put on this car along with some of the newer cars classed in GTLite relegated Bill to qualifying 17th on the grid. By driving steady and working hard to pick up spots, Bill brought the car up to 12th at the finish.

The first race Sunday Morning, and 19th of the weekend, was the Showroom Stock B class. Ralph Porter is still trying to make his Mini competitive, but is badly outclassed by the Honda Civic and Pontiac Solstice. Even though Ralph had a podium finish in SSC before the car was reclassified, the best he could get in this years SSB was 14th on the grid. On the first lap, in the first turn, some other cars tangled in front of Ralph, and with no place to go, Ralph ran into the other cars and finished his race before the second turn.



The numbers tell us we had some racers with great races and finishes, and others with considerably less luck and a tough tow home after the week. Congratulations to Jason Knuteson for his National Championship, and hoping it is the first of many!!

By the time this is printed and distributed, the rally will be completed.*) Feel free to study these and e-mail questions to Ted by October 30. Questions should be in a form that can be answered yes, no, or will not occur. He will post the answers at registration. Feel free to fill in a Registration Form on-line and e-mail it to me as well (GTA competitors need to use the EN form.). Then all Ted has to do at registration is see your drivers license, collect your money, and have you sign the liability waiver (and fill out a temporary membership form if you are not a member).

For those of you who would like to do more rallying, but would like to stay within day-trip radius, there is a Campaign County Sports Car Club in Champaign, IL that is putting on a pretty nice series of events.

To qualify for the program, the new member may not have been an SCCA member in the previous 18 months.

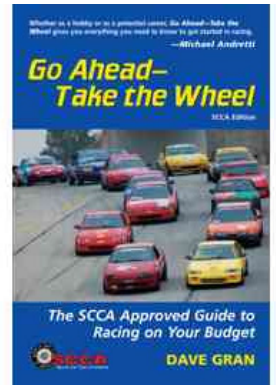
In order to receive credit for referring a new member, the recruit must provide your name and membership number when they sign up. This may be done via SCCA.com (preferred), phone, fax or mail.

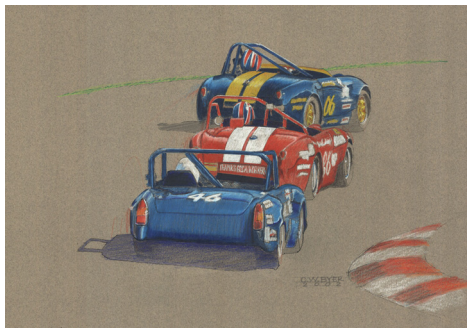
