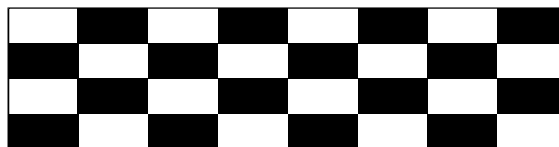

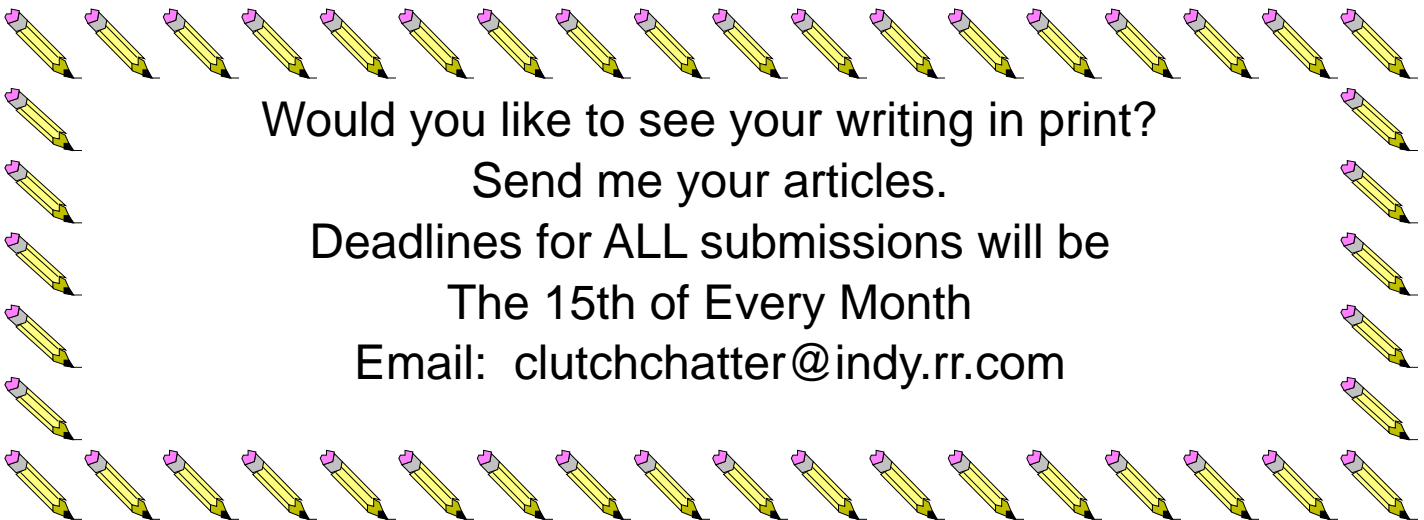
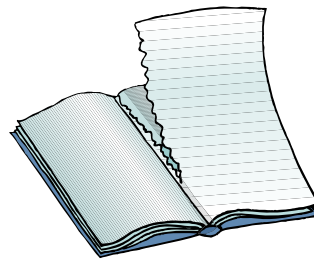
Solo Solo Spring Training has been scheduled for March 20 at Andersen Logistics, with Indy Region Solo Annual Tech the same day.

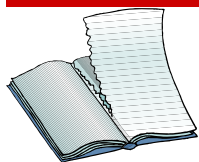

This is a synopsis of the minutes of the meeting of the Indy Region BOD February 8, 2010 at Dooley O'Tooles, 6:30 PM. There were 9 directors and 3 guests present. Minutes of the previous meeting were approved.

Old Business: BOD At Large Members. The elected Directors voted for the 5 At Large Directors from 7 candidates. The appointed At Large Directors for 2010 are Chuck Hanson, Scott Thomas, Andy Welden, Will Lahee, and Charles Lemerou. The BOD Thanks Geoff Chambers and Steve Linn for also volunteering to serve, and hope to continue receiving their counsel on club matters.

Treasurers Report Rich emailed the report to everyone before the meeting. After minor discussion, the report was approved.

Clutch Chatter Pauletta set a deadline of Feb. 20 for articles for the Feb/March issue. Everyone is to review the region awards points rules for any changes, and get them to Pauletta for publishing.

Website John has the website up to date, and has volunteered to be our webmaster for 2010.

Membership Pauletta reported current membership is 448. Raleigh and Velma Boreen reported on some membership seminars from the National Convention.

Activities The next Club Nite Out (CNO) will be March 2 at O'Tooles. We will continue to have the CNO's on the first Tuesday each month, and alternate between O'Tooles (odd # months) and GT Souths BBQ on Emerson in even months.

Rally Indy Region received the Regional Rally Achievement Award at the National Convention, a Great Honor to our program and leaders.

A Rally schedule has been proposed for 2010, with 9

events currently listed. The schedule will be in CC in Chuck's Rally Report. All of our Rally Steering Committee members have now become Rally Safety Stewards.

Race Dave Dusterberg is our Race Chair for 2010. Dave will call another meeting of the steering committee as soon as convenient. Dick Powell will gather info for a Season of Racing flyer to be mailed as soon as possible.

The May race at Bluegrass Motorsports Park Has been cancelled due to delays at BMP. We have been assured that the track will be ready for the August Nationals weekend, and we will be the first competition event at BMP.

Solo Clemens Burger was named Solo Driver of the Year at the National Convention; congratulations, Clemens!!

Raleigh and Velma have arranged the Solo Spring Training for GLDiv and Indy Region for March 20 at Andersen Logistics. More info will be presented in CC. The day will also include Annual Tech for both Solo and Race vehicles.

Solo schedule has been proposed for 2010, with 7 points events and 3 fun events. Midwest Sports Complex has changed their rental requirements and is consequently out of our range now; we will not be able to have an event there this year. Scott has been conferring with some of the margue clubs for possible combined events. Ben Newburn is contacting the Subaru People for their event in 2010. Raleigh is working with Connersville for the Visteon site, and working on a Grissom Test 'N Tune day for May 1-2 weekend.

Scott reported on the investigations to find a replacement for daBus. The BOD unanimously approved a line item for the 2010 budget to get a Bus when available: Scott and Dave D. to continue to find a Bus.

The first planning meeting for the National Tour Solo for Grissom July 4 weekend will be held March 4 at Boreens; more info and directions will be in CC.

New Business Next BOD meeting scheduled for March 8 at O'Tooles. Meeting was adjourned.

Descriptions and Criteria for Indy Region Special Awards

Michael Buchanan Fairbanks Memorial Award Competitor of the Year

The first award the Indianapolis Region ever presented was the High Point Award, which went to the driver scoring the most points in all of the Indy Region's events. It was first presented in 1952 to Bob Magenheimer, driving a 1948 MG TC that is now owned by Indy Region member and National SCCA Club Historian Peter Hylton. Bob repeated the feat and won the award again in 1953. Then in 1954, Mrs. Joseph Daniels donated a large silver plate to the region as the Michael Buchanan Fairbanks Award. It was named after her son, who had died in a car crash while attending DePaul University. As a matter of interest, Michael happened to be the grandson of Charles W. Fairbanks, Vice President of the United States under Teddy Roosevelt from 1905 to 1909. The new Fairbanks Award replaced the High Point Award, and continued to be given to the top competitor across all forms of competition in the Indy Region. As the club evolved into having more and more events, this interpretation evolved such that the award was given to the top competitor who competed in all forms of competition. This is a subtle distinction, but an important one. Originally it did not matter what events you competed in, you scored points in any event you ran, and they counted toward the award. In the later interpretation, you HAD to compete in all forms of competition. This is the reason that in the seventies the Fairbanks Award was not always presented. Unless someone scored points in all three disciplines of Racing, Rally, and Solo, they were not eligible to win the award. In 1982, after the Fairbanks Award had sat in a closet for 4 of the 6 previous years, the Indy Region Board of Directors created a new Competitor of the Year Award, using essentially the rules we have today. However, a number of long time members objected to eliminating the Fairbanks Award, so the original plate was brought back, mounted on the base we have today, and the name of the award was officially changed to the Michael Buchanan Fairbanks Memorial Competitor of the Year Award.

**The Jack Hergenroether Memorial Trophy
A Perpetual Trophy Awarded Annually To The Outstanding Competition Driver
Indianapolis Region, SCCA
Dedicated 1965**

In 1956, Jack Hergenroether, a long time Indianapolis Region member and one of the people who helped get the region started, died in a motorcycle accident near Greenfield, Indiana. Indy Region member John McGee was instrumental in inaugurating the Jack Hergenroether Memorial Trophy, represented by a large silver bowl. It was to be presented to the top race driver in the Region on the basis of attitude, sportsmanship, competitiveness, and the manner in which the driver represented the Indianapolis Region. After the first couple of years of presentation, the selection of each year's winner was turned over to the past recipients of the trophy. The award carried a great deal of respect and as time passed the winners became a rather elite group. They placed the selection criteria very high with an emphasis on racing success, such that one had to almost win a National Championship just to be eligible to win the trophy. At the 1979 Indy Region Awards Banquet, the selection committee of previous winners announced that they did not feel anyone had performed well enough to earn the award that year, so they were not going to present it that year. Frankly, the membership was rather taken aback by the decision. The same scenario repeated again in 1980, and the Indy Region Board of Directors took matters into their own hands, reclaiming the Trophy and choosing Greg Graham as the 1981 recipient. The Board of Directors selected the winners over the next several years, but then again decided to turn the winners selection over to the past recipients of the Trophy, with instructions to put equal emphasis on all of the original criteria, not just on the ultimate competition success part.

The e-mail burned bright on my computer screen in October just a few days after the USRRC in Lacrosse, WI; Rally master, John Sears, was considering four GTA road rallies in one weekend in January in sunny Arizona. I don't remember if I called my navigator, Susan, first or if I immediately e-mailed John to let him know I was interested. I think I e-mailed John. Arizona in January would have been enough to give me pause, but four rallies done by the same rally master in one weekend was more than I could pass up.

As you might know, Susan and I have been running road rallies together for a couple of years. We typically approach rallying as a learning experience and, over the past couple of years, we have learned a lot about the GTA rallies that are organized in our Region. The opportunity to travel to a different region with unfamiliar roads and run four different rallies was also something that Susan didn't want to miss – OK, the promise of sightseeing in warm, sunny Arizona helped, too. And so it was, that while the rest of Indianapolis was being snowed on by the biggest, coldest storm of the year, Susan and I were on a de-iced plane headed to Phoenix.

We learned at dinner on Friday that there were only four cars entered for the rallies. The other three teams were made up mostly of Grand Master rallyists. I felt bad for John that there weren't more cars entered, but I was glad that we would have the chance to learn from some masters of the sport. Grand Master rallyist and great race veteran, Bruce Gezon, told us that John's rallies are different than anything else we had run and that we should expect to do poorly on the first rally, but much better on the second.

Susan and I are used to rallies that are fraught with course-following traps. If you mess up, you're going to end up somewhere you don't want to be and you will be very late coming into checkpoint. The traps in John's rallies were mostly on paper. Is the name of the road Rita or Reeta? Do you see "Tucson City Limits" or is there other verbiage in the middle of it? Be careful, route instruction 29 is written on the page before route instruction 28 and the General Instructions clearly state to execute route instructions in numerical order. Don't turn on "Agassiz" because you can't turn on a sign; You can, however, turn on Agassiz because the lack of quotation marks means that it's a road, not a sign.

Bruce was correct. We placed 4th in the first rally by missing 14 points. The winners and 2nd place finishers missed none. Third place missed 3. Bruce was also correct that this was our worst rally of the weekend. By the time we ran our 4th rally, we were running in the same league with everyone else and tied with 2 other cars for 2nd place by missing 1 point. Once again, the winner missed none.

It might have been frustrating that most of the traps were paper instead of course-related, but that depends on why you rally. I rally because I like the excuse to get in my car, find a winding road with scenery that most of the general population hasn't experienced and Drive with a capital D. On that note, John's rallies were excellent.

We saw two different good size portions of Southwest Arizona. In addition, there was plenty of time to finish the rallies, so we had the opportunity to stop and enjoy some of the sights along the way. On Sunday, we stopped at a Mission, took pictures and did a little hiking. The route instructions were given to us far enough in advance that Susan and I could pour over them together and spot the potential traps. Then, armed with two sets of route instructions, Susan, as navigator, didn't need to keep her head buried in her papers and we could both enjoy the scenery including a roadrunner that ran in front of our car on Sunday causing both of us to cheer the fact that we had seen one.

It was a wonderful mini-vacation in the middle of the cold, snowy Indiana winter. Because there were four rallies all written generally the same way by the same rally master, we were able to build on the knowledge learned from the previous rally to fully enjoy relaxed, scenic driving in an area of the country that we hadn't fully explored in the past. I'd do it again and would definitely recommend doing the same to anyone that wants an excuse to drive some less-traveled roads.

Competitors in the Course category will execute either the “A” or “B” part, whichever can be executed first in a course directing manner (i.e. it causes you to leave the main road as defined by the MRD’s in effect. They will then ignore the other part. They will be given an answer sheet on which they will identify which part of the instruction they executed, and also write in their answers to the questions.

1. Minors

All Minor's (competitor or spectator) at the event site MUST be accompanied by at least one parent (or legal guardian) during the entire course of the event. The parent (or legal guardian) must complete a Minor Liability Waiver for all accompanied Minors at the site. For Minor Competitors, BOTH parents (or legal guardians) MUST sign a Minor Liability Waiver before the minor may be allowed to compete. Proof of full legal custody is required for single-parent households. A parent (or legal guardian) of any Minor Competitor MUST remain at the event site until the completion of the event.

Copies of the Minor Liability Waiver are available before events upon request.

2. 4 Wheel Drive or High Center of Gravity Vehicles

Due to the increased chance of rollovers, 4 wheel drive vehicles (not AWD) or vehicles with a high center of gravity and a narrow track are not allowed. Examples of excluded vehicles include but are not limited to:

Any vehicle on light truck rated tires.

Any vehicle with a 4-wheel drive transfer case.

Any full size van.

Any mini-van.

Any vehicle with a lift kit.

Any vehicle with a wheelbase exceeding 116 inches.

Any vehicle deemed by the Solo Chairman, Event Chairman, or Solo Safety Steward to be at risk of a rollover.

Examples of vehicles: Suzuki Samurai, Jeep CJ series, Geo Sidekick, Chevy Blazer, Ford Explorer, Dodge Caravan, Honda Odyssey, Ford F150 4WD, Dodge Ram 4WD, Chevy Silverado 4WD

3. Uncompleted Work Assignments

All competitors MUST complete their scheduled work assignment in order to be eligible for event trophies or year-end points. If a competitor does not complete their work assignment during their scheduled time, the competitors scheduled runs will be forfeited and entry fee will not be refunded. If the competitor does not complete their work assignment after completing their scheduled runs, the competitor will be disqualified from the event, will not be eligible for trophies, and will not score any points towards year-end awards. If it is

documented that a competitor has skipped work assignments at more than one event during a season, the competitor will be subject to possible exclusion from competing in future events per the Solo Chairman's discretion.

4. SMS Class (Indy Region Supplemental Class)

The purpose of this class is to cater to street driven vehicles that may have one or two modifications that immediately places the vehicle into the "catch all" SM class; and for the competitor who does not intend to run on a National level, but to modify their car to their liking for the street.

This class follows all of the normal Street Modified SCCA National Class rules, except for the following:
- Tires must have a treadwear rating of 140 or greater.

- The PAX multiplier for the class shall be 97.5% of the current SM PAX multiplier.

5. Car numbering and lettering.

Per National rules, numbers must be a minimum of 8" high with a 1.25" stroke. Class letters must be a minimum of 4" high with a 0.75" stroke. They may be made of any durable material that contrasts with the car's paint. We will allow tape as long as the finished product meets requirements and are on the car before tech occurs. The correct width tape in different colors will be provided at the event for people who don't bring their own numbers. "Shoe polish" numbers will not be allowed.

Positioning the numbers on the car's paint is preferred, but numbers may be placed on the car's rear-side windows with the following conditions: The numbers/letters must meet size and material requirements (no shoe polish). The window must be adequately tinted so high contrast is maintained. If the tinting allows much light/detail to pass through the window, then the high contrast is lost and won't be allowed. The numbers and letters do not have to be the same color, as long as high contrast is achieved. So, panel numbers that are the correct size, and have high contrast with the panel, can be used with a different class color to maintain contrast with the car color.

2010 Indianapolis Region Race Awards Points Rules By: Dave Dusterberg

RACING AWARDS Purpose: To recognize the maximum number of Indianapolis Region of Record members by presenting year-end racing awards. The awards and their criteria are as follows:

1. The Jack Hergenroether Memorial Trophy is the premier road racing award in Indianapolis Region. It shall be presented to the outstanding competition driver on the basis of attitude, sportsmanship, and competitiveness, and the manner in which the driver has represented the Indianapolis Region. The recipient is selected by a panel of the previous recipients of this award.

2. The Club Racing Rookie of the Year Award will be presented to the competitor accumulating the highest total points, awarded per GCR, for the best six finishes in regional and/or national events counting for Indianapolis Region points as defined in Rules 3 and 4 below. In the case of a tie, multiple awards will be presented to the winners. The competitor must:

- a. have never previously held an SCCA racing license and
- b. begin the season on a Novice Permit and meet National license requirements during the season.
- c. Rules 6,7,8,9, and 10 will apply.

3. Regional Racing trophies shall be awarded for the 1st through 5th places on the following basis:

- a. Points will be accumulated per GCR for the best six regional event finishes of which no more than two may be outside of Great Lakes Division.
- b. Rules 5, 6, 7, 8, 9, and 10 will apply.

4. National Racing trophies shall be awarded for the 1st through 5th places on the following bases:

- a. Points will be accumulated per GCR for the best six national finishes in a single class, of which no more than two may be outside of Great Lakes Division. Finishes at the SCCA National Championship Runoffs will be considered an out of division finish. Finishes at the SCCA National Championship Runoffs will be considered an out of division finish.

b. Rules 5, 6, 7, 8, 9, and 10 will apply.

5. A driver will be eligible for only one National Racing and only one Regional Racing award, but may receive one at each level.

6. All activities covered under a unique sanction number shall be considered to be a single event.

7. If during the conduct of a single event multiple opportunities exist for a class to race, only one race will be permitted to count for points. If the format consists of preliminary races (e.g., qualifying race) followed by a feature race, only the feature race shall be counted. If the format consists of a special race for some classes (e.g., handicap, enduro) in addition to a normal race equal in length to that provided for all other classes, the race of normal length shall be counted. In the case that a class receives only one opportunity to race during an event, that race shall be counted, even if it is not of the same length as the races afforded to other classes.

8. The points standings will be published at mid-season and at the end of the year in Clutch Chatter.

9. It shall be the responsibility of each driver to supply the points keeper with results throughout the season.

10. Competitor must be an Indianapolis Region and SCCA member in good standing to be eligible



1. General:
 - a. All Indianapolis Region road rallies will be year-end counting championship point rallies unless otherwise noted. "Non-point" rallies such as fun rallies will be clearly advertised as such.
 - b. Year-end championship awards will not be awarded unless the region conducts a minimum of three points events.
2. Classes of Competition: Classes of competition on points rallies will be determined by the rallymaster and/or the rally chairman. The classes will be drawn from one of the following two groups:
 - a. Group I classes are to be used for TSD (Time, Speed, Distance) rallies.
 1. Class "E": Unlimited equipment. Comparable Divisional and National class is "Equipped".
 2. Class "L": Any timekeeping device, any odometer, any computer/calculating equipment that does not have automatic input of mileage, tables, Curta's, or slide rules. Comparable to National and Divisional class "Limited".
 3. Class "S": Any timekeeping device, stock odometer in stock location. Tables, slide rules, or single memory four function (non-programmable) calculators. Comparable to National and Divisional class "Stock".
 4. Class "N": (Novice) Same as Class "S," except that neither the driver or navigator may have had a first place finish where they finished ahead of someone else in class on any SCCA competition rally, nor have been awarded a year-end rally trophy by any SCCA Region when they enter their first event of the season. Any Team that qualifies as a Novice at their first event of the season shall remain a Novice Team for the balance of the season.
 - b. Group II classes are to be used for non-TSD rallies - rallies sometimes know as gimmick rallies. Examples of this type of rally would be a map rally or GTA(Game-Tour-Adventure).
3. Member's Qualified Points: A determination of a member's qualified points for a year-end championship award will be accomplished or affected by the following:
 - a. A member's best finishes in 75% of the region's declared points events or best 6 finishes, whichever is less, will be counted toward a year-end championship award. Note! - A 75% multiplication factor resulting in a .5 event will be rounded up. Example: 6 events x 75% = 4.5 = 5 events to be counted toward an award. Otherwise, events will round to nearest whole number. The above will be done on a basis of:
 1. For rallies with more than one class other than Novice, points will be awarded for class position per the points schedule.
 2. For rallies with one class other than Novice, points will be awarded per the points schedule, with the points to be counted in the class giving the competitor the greatest advantage.
 3. For a rally of chance (such as Poker Run, Yahtzee Rally, etc.), all competitors who finish will be awarded second place points regardless of finishing position.
 - b. Points will be counted only for Indianapolis Region members. Anyone who joins on or before September 1st in a given year will receive points for those events run as a non-member. Anyone who joins after September 1st in a given year will receive points only for events run after joining the Indianapolis Region.
 - c. The member must compete in one given class in a minimum of three (3) or 50% of the region's rally points events, whichever is less. (Round up for odd number of events).
 - d. Both the driver and the navigator will receive the same number of points.

- . Members must qualify their points by working one Indianapolis Rally SCCA event or seek work agreeable to the Rally Chairman, i.e., pre-checking, acting as safety steward. The Rally Chairman will be responsible for keeping a record of those people who have fulfilled the work requirement towards year-end point eligibility.
- f. Members staging or writing a rally; i.e., being a rallymaster, will earn 12 points in the class in which they compete during the majority of the season.
- g. For rallies with only Experienced and Novice classes, competitors must inform the Rally Chair at that rally which class they want to apply their points for year end total. In rallies with all classes, a person can only get points for the class they compete in for that rally.

4. Publication of Points:

- a. The rally chairman will be responsible for tabulating and publishing the points.
- b. At a minimum, the current points standings will be printed in the regional publication before the next to last scheduled points event.

5. Year-end Awards: Year-end awards will be determined per the following format:

- a. Year-end awards will be awarded to competitors earning the highest points totals by class.
- b. Competitors eligible to receive awards in more than one class will receive them only in the class giving them the highest year-end finishing position. If competitor's season ending point totals are the same in two classes, they will receive an award in the higher ranked class.

Classes will be ranked in order as follows:
E > L > S > N

- c. Anyone who qualifies as a novice at the beginning of the season will count all points gained that year toward the novice class standings. (See II.A.4)
- d. Ties for year-end awards will be broken on the basis of quality of finishes; i.e., number of firsts, seconds, etc.
- e. The number of awards presented in each class will be per the following awards schedule:

| 1 to 2 | 1 |
| 3 to 6 | 2 |
| 7 to 10 | 3 |
| 11 to 14 | 4 |

6. Junior Award:

- a. Must be under age 18 on February 1st of the award year.
- b. Juniors may be a driver or navigator
- c. At each applicable event, in addition to the class trophy, a Junior trophy will be awarded to the highest placing Junior overall.
- d. 1 year-end Trophy will be given to highest placing Junior overall.



I am a member of the nearby Central Illinois Region. I participated in several Indy Region Road Rallies this past year. Your Rally Chairperson, Chuck Hanson, was extremely helpful and went out of his way to encourage me to take my performance to the next level. He went so far as to assist me financially so that I could attend the national season finale, the United States Road Rally Challenge, in LaCrosse, Wisconsin. The points I earned at that event elevated me into first place in the SCCA National Tour Rally Sportsman Championship season points standings. Without Chuck's help, I would not have been able to earn that Championship.
