Minutes– November BOD Meeting

This is a synopsis of the minutes of the meeting of the Indy Region BOD November 8, 2012 at Dooley O'Tooles, 6:30 PM. There were 11 directors and 3 guests present. Minutes of the previous meeting were approved.

Treasurers Report Rich emailed the report to everyone before the meeting. We will have a slight loss for the year. After minor discussion, the report was approved.

Clutch Chatter New Editor is John Strathman from Lafayette. He will work with Josh Kikta on the December issue, and then expects to take over in January.

Membership Stephanie reported current membership is 377. There are 3 new members, some expiring this month. Stephanie will be the Solo Chair next year, so we need someone for the position of Membership Chair.

Website John emailed a report to the BOD before the meeting. He reminded everyone that the awards points rules for 2013 need to be published prior to the first competition event; expected to be a Rally in January.

Activities Plans are going ahead for the Annual Meeting and Awards Banquet on January 19, 2013. Dave discussed a display at the World of Wheels Car Show in February; everyone generally agrees it will be worthwhile.

Dave mentioned that Grissom needs more activities to keep the site available for our use. He suggests we try some events in the style of Pro-Solo (drag race start for 2 cars on mirror image courses).

Rally The October Rally was a success, with 9 cars, including 3 cars of new Novices. Thanks to Ted Drummond for a great and Fun Rally. The November Rally is the weekend after Thanksgiving, sanction has been received and Rally is ready.

Sam Crites and Chuck are working with other clubs in the area for a Challenge Rally, using teams of 3 cars. There is already quite a bit of interest, could be a huge Rally.

We have 2 National Champions within our Rally program. Wendy Harrison is (again) the GTA Sportsman National Champion, and Charles Lemerou is the Sportsman Course National Champion. Congratulations to our Rallyists for their achievements!

Race Andy has been approached by Michigan International Speedway to put on an SCCA National Race. He has reviewed the track and believes it could be possible. He will continue to communicate with Western Michigan Region for more details.

Solo We had a good season for entries (average over 80 per event) and revenue, but also had some extra expenses for equipment, so will have a net loss for this year. Our new venue (Speedrome) has already asked us to have events there next year, as has Connersville. We have also been contacted by One Lap of America to put on a Solo event for them next year.

RallyCross Program We have been approached by a group near Attica to use our timing equipment for their RallyCross event. Pauletta discussed the standard contract she uses for the Subaru event, and could possibly rent the timing equipment. Chris Brake will give them the option of renting our equipment and personnel for a fee.

Elections Velma Boreen has agreed to be the Election Chairperson for this year. Dick Powell will prepare a nomination ballot for the website with copy to Velma and Josh.

Sam Crites has volunteered to run for Assistant R.E., adding to Dave Dusterberg for R.E., Rich Lankford for Treasurer, and Chris Brake for Activities Chair. We are hoping for nominations for all elected positions from the website posting of the nomination ballot.

Once we have nominations, Velma will work with Josh Kikta and Dick Powell to prepare the voting ballot and Meeting Notice for mailing.

New Business Next BOD meeting scheduled for December 13 at O'Tooles. Meeting was adjourned.

The November rally was Nasty compared to the rest of the month, but certainly not unexpected for this time of year. One of our October novices came back to try their hands at a defined route rally. They did very well at following the instructions, attempted to maintain the speeds and finished clean. Here's hoping that they join us as regulars.

We had a total of six cars and the GTA Championship for the Region was determined. Don't have the data, but the Competitor of the Year was also in play, and we think, decided by the results of this event. All of the GTA competitors cruised through the route, but the Course competitors all over thought themselves and created traps that didn't exist. They needed to remember that this was intended as a Regional event that would be suitable for beginners.

You will note that the tentative schedule for next year has a lot of TBD's (To Be Determined) entries. This is because the Committee has been so busy running rallies that we haven't had time to meet and determine who will be doing what. We did meet with the Solo group last month and they have adjusted their schedule so that it doesn't conflict with either the Car Club Challenge or the double National. We sincerely thank them for their cooperation. It is the goal of the Region to present a broad variety of events for the competition pleasure of our members; with a goal of making it possible for you to compete in a variety of venues and disciplines.

A few words about the Car Club Challenge. John Calhoun, who was a very successful National competitor in the 70's and 80's, came to us a couple of months ago with a proposal to present a Challenge Rally for car clubs in Central Indiana. He had identified fifteen clubs. The event will be a "Team" Challenge where clubs enter "Teams" consisting of three rally cars. The cars compete individually in the event, but the "Team" score will be the sum of the "best two" cars. Low "Team" score wins the trophy for their Club. At least one Club member must be in each car, and if the Club represents a marque, then they have to compete in a car from that marque. We are pleased to say that we have six Clubs that have stated that they want to participate, and some of them have asked if they are limited to a single "Team." Answer: NO. We are highly encouraged by the response!

NOMINATIONS FOR 2013

We are rapidly approaching the time to elect our officers for the year 2013. Now is the time for anyone desiring to be more involved with the running of our club to step up and enter their nominations for office in our region. This is a general description of the various offices, and a nomination Ballot. If you wish to run, or you know someone else who wishes to run for office, please contact our nominations chairperson Velma Boreen and let her know.

Region Officer Job Descriptions

It's getting near that time of year when Regions are considering new officer candidates for 2013. To help us recruit new leaders, we present the following Job Descriptions for Region Officers. This list is by no means comprehensive, and is only offered as a guide for us during the upcoming elections.

Regional Executive

- Chief Executive Officer of the Region.
- Official Spokesperson for the Region.
- Presides at all meetings of Members and Directors.
- Shall report on the status of the Region at each meeting.
- Shall call any special meeting of Members and Directors in accordance with the Bylaws of the Region.
- Prepares and adheres to agendas for all meetings.
- Shall appoint or discharge necessary and appropriate positions and committees.
- Shall sign and execute, together with the Treasurer (or his assignee), all contracts, notes, and drafts in the name of the Region.
- With the Treasurer, participate in creating and assist to determine the Region's budget for the coming year.
- Shall perform or cause to be performed all duties assigned to him/her by the Sports Car Club of America, Inc.
- Shall cause books, statements, reports and other certificates and records to be filed as required by law.
- Shall complete (with aid of Assistant RE) Region SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Shall complete SCCA Directory information for the Region and submit to the National Office no later than December 31st of each year.
- Shall enforce Region's Bylaws and perform all duties incidental to the office of Regional Executive.
- Shall supervise all activities of the Region.
- Shall have other such duties and authorities as prescribed by Bylaws or Regions Board of Directors.
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Communicate as needed with Executive Officers of other local sports car clubs, SCCA Regions, and SCCA Divisions.
- Shall maintain communications with the responsible SCCA Area Director.

Assistant Regional Executive

- Performs duties of the Regional Executive in that person's absence or incapacity.
- Performs other such duties as assigned by the Regional Executive.
- Performs duties as assigned by the Region's Board of Directors.

rectors.

- Shall attend all meetings of the Members and Directors.
- With the Regional Executive, shall prepare the Region's SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.

Secretary

- Shall keep minutes of meetings of Members and Directors.
- Shall be the custodian of all records of the Region.
- Shall attend all meetings of the Members and Directors.
- Work closely with the RE and Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Shall maintain the Region's calendar of events.
- Shall submit the Region's calendar to newsletter and website.

Treasurer

- Shall have care and custody of, and be responsible for all funds, merchandise, and assets of the Region.
- Shall have custody of monies, debts, and financial obligations of the Region.
- Shall attend all meetings of the Members and Directors.
- Reports financial status of Region to Members and Directors.
- Shall maintain accounting records in accordance with Generally Accepted Accounting Principles.
- Pays listing or sanctioning fees in advance of any SCCA event.
- Shall transmit dues and income information received from the SCCA National office to the Region's Membership Chairperson.
- Shall make monthly, or more often if required, deposits to the Region's bank account.
- Obtain tax exemption certificate if required.
- With the Regional Executive, participate in creating and assist to determine the Region's budget for the coming year.
- Work closely with the RE and the Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc.
- Shall ensure preparation and filing of tax returns in accordance with the Internal Revenue Code of the United States and other controlling jurisdictions.
- Shall notify the Region's bank(s) when changes are made with respect to addresses, signatures, and other contact information for new officers or check signers.

Membership Chairperson

- The Membership Chairperson promotes continued growth of the Region through actively recruiting new members and retaining current Members.
- Shall be the Chairperson of the Membership Committee.
- Shall make new Members and other interested parties feel welcome at all Region events.
- Shall maintain a list of Members and other interested parties. The list shall include all available contact information.
- Shall prepare an annual Region roster.

Other Directors or Officers

- Shall attend all meetings of the Members and Directors.
- Shall perform such duties and have such powers as assigned by the Board of Directors
- Work closely with Region Board of Directors to create and monitor one year and five year plans using guidelines offered in the Mission Statement and Strategic Plan of SCCA, Inc. May be assigned as liaison to committees and specialty chiefs who are not already members of the Region's Board of Directors.

Non elected positions of importance

Editor

- The newsletter editor generates a periodical publication and distributes it to all Region Members and other interested parties.
- Shall produce a publication that is professional appearing and easy to read.
- Generates content that is relevant to the Region and SCCA activities.
- In cooperation with the Region's Secretary, shall generate a calendar of events.
- Shall include reports of all the Region's events.
- Shall work closely with the Region's Webmaster to ensure accuracy and timeliness of shared information and stories.
- Shall secure advertising to offset publication costs.

Webmaster

- The Region's Webmaster designs the webpage and maintains content that is relevant to the Region and SCCA activities.
- Maintains a professional and easily navigated site.
- Ensures that the website is updated on a regular basis and is timely.
- Collect stories, features, and pictures for web content.
- Works closely with the Region's newsletter editor to ensure accuracy and timeliness of shared information and stories.
- In cooperation with the Region's Secretary, shall generate a calendar of events.
- Shall include results from all of the Region's events.

Committee Chairpersons

- A committee runs each program established by the Region. Each committee shall have a chairperson who is responsible for managing their respective program in a man-

- ner they see fit and in accordance with the Region Bylaws.
- As required, shall attend meetings of the Membership and Board of Directors and shall report on activities of the committee at such meetings.
- Shall communicate with the Board of Directors and Regional Executive on a regular basis.
- Shall prepare and monitor a committee budget for the committee's annual activities.
- Submit items of importance to Region's publication and website.

Information for Area 4 Members

Dear Area 4 Members,

Although there is much to tell, I am going to wait until after the SCCA BOD Meeting next week to issue another Newsletter. There are a few items of importance that I wanted you to be aware of:

Great Lakes Division of SCCA, Inc.

When GLD Inc. was incorporated, it was set up with each of our 19 Regional Executives as voting members. This was great in theory, but has not worked. It is nearly impossible to get a Quorum to conduct any business. In the next few days, you will see an email from GLD of SCCA, Inc. President Steve Kammeyer that modifies the Code of Regulations to allow business to be conducted with a smaller group of key members. The new plan does not disenfranchise anyone. All RE's are still invited to participate. But, this plan makes better sense for how we are constituted. I wholeheartedly endorse it. The RE's will need to approve it. Please do so.

2013 GLD Driver's School at Waterford Hills

As you know, Drivers Schools are necessary to bring new participants into our sport. The problem is, they rarely make money for the Region. In the past few years, Great Lakes Division has sponsored the DS with mixed results. Last year, it was only the skill and planning of Verne Wandell that saved us from a catastrophic loss. In 2013, Great Lakes Division of SCCA will join with Waterford Hills to present a joint Driver's School. We will supply the marketing, some labor and assistance; Waterford Hills will run the school with the object of qualifying drivers for their SCCA license.
