

Obituaries: Wilbur (Will) Zobbe:



He was preceded in death by his beloved wife of nearly 60 years, Susan Lynne Wallace Zobbe; his parents, Clara Heinlein Zobbe and Wilbur August Zobbe Sr.; and his sister, Nancy Zobbe Midgley. He is survived by his children Kim Hogdal (John), Lee Ann Zobbe, Michael Zobbe (Rebecca), and Catherine Kuntz (Scott); five grandchildren; and eight great-grandchildren.

A graduate of Howe High School, Will continued his education at Butler University and Ball State University. He served honorably in the U.S. Army during the Korean War.

Will was the owner and operator of Metalcraft Manufacturing Inc., where he led the company for over four decades.

His passion for engineering extended beyond business into motorsports. As an active member of the Indianapolis Region Sports Car Club of America and the

Porsche Club of America, he held numerous board positions. Will was the Road Rally Chairperson in 1967. Will and his wife Sue were the Clutch Chatter editors in 1969, and Will was the Assistant Regional Executive for Indianapolis Region in 1970. Will was Indianapolis Region Competitor of the Year and Solo Chairperson in 1972 (Sue was Membership Chairperson in 1972 as well), and the Regional Executive for Indianapolis Region in 1973. He built and engineered multiple Porsche and Mazda racecars for SCCA and IMSA competitions—including a national championship-winning Mazda RX-7—and in 1975, earned the SCCA National Mechanic of the Year award. He also competed as a driver, achieving many wins and top finishes.

In retirement, Will joined the American Military Heritage Foundation and took pride in maintaining a PV2-Harpoon WWII airplane named Hot Stuff. He and Susan traveled to air shows across the country.

Those who knew Will will remember not only his ingenuity and work ethic but also his dry wit and subtle sense of humor.

This list is by no means comprehensive, and is offered as a guide for the upcoming election, which will be final at the 2025 Annual Meeting and Awards Banquet, on January 17, 2026, at the Biltwell Event Center.

Our current Treasurer has notified the BOD that he cannot continue in this role for 2026, so that is one known open seat at this time. All positions are to be contested. Please email bod@indyscca.org and/or election@indyscca.org if you are interested in being a candidate for any of the 6 elected director positions.

Regional Executive

- Chief Executive Officer of the Region.
- Official Spokesperson for the Region.
- Presides at all meetings of Members and Directors.
- Shall report on the status of the Region at each meeting.
- Shall call any special meeting of Members and Directors in accordance with the Bylaws of the Region.
- Prepares and adheres to agendas for all meetings.
- With Board approval, shall sign and execute, together with the Treasurer (or his designee), all contracts, notes, and drafts in the name of the Region.
- With the Board, participate in creating the Region's budget for the coming year.
- Shall perform or cause to be performed all duties assigned to him/her by the Sports Car Club of America, Inc.
- Shall Coordinate with the Treasurer and Secretary to cause books, statements, reports and other certificates and records to be filed as required by law.
- Shall complete (with aid of Assistant RE) Region SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Shall enforce Region's Bylaws and perform all duties incidental to the office of Regional Executive.
- Shall give guidance to all activities of the Region.
- Shall have other such duties and authorities as prescribed by Bylaws or Regions Board of Directors.
- Communicate as needed with Executive Officers of other local sports car clubs, SCCA Regions, and SCCA Divisions.
- Shall maintain communications with the responsible SCCA Area Director.

Assistant Regional Executive

- · Performs duties of the Regional Executive in that person's absence or incapacity.
- Performs other such duties as assigned by the Regional Executive.
- Performs duties as assigned by the Region's Board of Directors.
- Shall attend all meetings of the Members and Directors.
- With the Regional Executive, shall prepare the Region's SCCA Charter Documents and submit to the National Office no later than February 15th of each year.

Secretary

- Shall keep minutes of meetings of Members and Directors.
- Shall be the custodian of all records of the Region.
- Shall attend all meetings of the Members and Directors.
- Shall maintain the Region's calendar of events.
- Shall submit the Region's calendar to newsletter and website

<u>Treasurer</u>

- A. Shall have care and custody of, and be responsible for all funds, merchandise, and assets of the Region.
- B. Shall have custody of monies, debts, and financial obligations of the Region.
- C. Shall attend all meetings of the Members and Directors.
- D. Reports financial status of Region to Members and Directors.
- E. Shall maintain accounting records in accordance with Generally Accepted Accounting Principles.
- F. Pays any listing or sanctioning fees in advance of any SCCA event.
- G. Pays invoices submitted to the region by outside vendors, Program Directors, or others.

- H. Shall transmit dues and income information received from the SCCA National office to the Region's Membership Chairperson.
- I. Shall make monthly, or more often if required, deposits to the Region's bank account.
- J. Obtain tax exemption certificate if required.
- K. With the Regional Executive, participate in creating and assist to determine the Region's budget for the coming year.
- L. Shall ensure preparation and filing of tax returns in accordance with the Internal Revenue Code of the United States and other controlling jurisdictions.
- **M.** Shall notify the Region's bank(s) when changes are made with respect to addresses, signatures, and other contact information for new officers or check signers.

Membership Chairperson

- The Membership Chairperson promotes continued growth of the Region through actively recruiting new members and retaining current Members.
- Shall be the Chairperson of the Membership Committee.
- Shall make new Members and other interested parties feel welcome at all Region events.
- Shall manage the Involved Members recognition program.

Activities Chairperson

- Manage all details of the January Annual meeting with guidance from the Board of Directors.
- Collaborate with other SCCA region officers and chairpersons (e.g., Solo Chairman, Rally Chairperson) to
 ensure a cohesive and well-rounded regional calendar.
- Communicate event details and information to the membership through newsletters, websites, social media, and other channels.
- Coordinate with the Membership Chairperson to promote membership growth and engagement by developing outreach initiatives and creating a welcoming environment for new and potential members at events.
- Work with the Regional Executive and Board of Directors to ensure activities align with the region's goals
 and the overall mission and vision of the Indianapolis Region SCCA

Other Appointed Directors

- B. Shall perform such duties and have such powers as assigned by the Board of Directors
- C. May be assigned as liaison to committees and specialty program managers who are not already members of the Region's Board of Directors.

Via email, BOD member Del Bartlett assigned his vote by proxy to Darren Daubenspeck should any votes be taken. Via email, BOD member Bruce Faucett assigned his vote by proxy to Chuck Hanson should any votes be taken, bringing the quorum tally to 11.

Meeting Called to Order: 6:35 pm

August meeting minutes approved. Motioned by Darren D. Seconded by Keith H. None opposed, motion is approved.

A. Officer Reports:

1. RE Report:

- a. The last transmission of data for the State AG request for information has been sent. Dell Bartlett's interviews and summaries of fact finding have been sent.
- b. Nothing out of the ordinary to report to the Board.
- 2. ARE Report:
 - a. Clutch Chatter article submissions needed by this Saturday.
 - b. Discussion of the Board of Director's elections for 2026.
 - 1. Chris Wheatley volunteered to be the Chair of the Election Committee.
 - 2. Chuck H. volunteered to assist on the Election Committee
 - 3. Motion to appoint Chris W. as the Chair of the 2026 Election Committee given by Darren D. Seconded by Wendy H. None opposed, motion is approved.
 - 4. Six elected positions of the Board are not likely to change, except for a potential change of Darren D. considering the Treasurer position and Dave C. moving into the Assistant Regional Executive position.
 - c. Several Days ago Dell Bartlett sent out statements regarding Conflict of Interest and Whistleblower compliance. Still waiting on a few signatures.
 - d. Discussion of Social Media Chair.
 - 1. The Instagram account is still not under Region BoD control.
 - Kieth H. volunteered to become the Region Social Media Coordinator.
- 3. Treasurer Report:
 - One Lap of America payment is still pending. They maintain a check was sent, but it has apparently been lost.
 - b. Chuck N. is corresponding with the One Lap organization for the re-issuance of the payment.
- 4. Membership Report:
 - a. 9 New memberships, 5 new weekend members, 13 expired memberships, 531 current members
- 5. Activities Report:
 - a. IMSA event at IMS group space or package of tickets did not make financial sense this year.
 - b. An informal gathering at the event on Sept 19-21 will be organized by Ethan.
 - c. A local Cars and Coffee event is Saturday, September 13th at Dallara Experience Hub. Charles T. & his car will be featured in their showroom.
 - d. Car Show at Lincoln Tech Indianapolis on Oct 3rd.
 - 1. Member presence is requested due to Solo Fun #2 will be at the site the following week.
- 6. An open house at BrenSpeed in Pierceton, IN on Sept. 20th was mentioned.
 - a. BrenSpeed specializes in Mustang performance
 - b. Complementary dyno pulls advertised.
 - c. Dustin H. plans to solicit for member attendance.
- B. Appointed Director Reports:
 - 1. Solo Report:
 - a. Indy Region Points Event # 7&8 on Sept. 27th and 28th.
 - b. Unknown if both days are GLSS Points Events, Chair will check and advise.
 - c. Chuck N. would like help securing another site that is closer to the Marion County Area.
 - 2. RallyCross Report:
 - a. Event was held on Sunday Sept. 7th at Badlands in Attica, IN.
 - 1. One incident report filed, no injuries.
 - 2. Event income is known, but still waiting on a few charges for the financial report.
 - 3. The event had minimal promotion and lower than expected attendance.
 - 4. Internal RallyCross Chiefs for hosting the event requested by Solo Chiefs.
 - 5. Solo Bus and equipment was used for this event.
 - b. The next RallyCross event is scheduled for Nov. 9th.
 - 1. Event conflict with Milwaukee Region may force date movement.
 - Website information also needs to be updated with Mike Herrera as Chair as well as dates, rules, etc.
 - 3. RoadRally Report:
 - a. Halloween Rally will be held Oct 25th.
 - 1. Discussion of promotion of the event.
 - 2. Starting site in Cloverdale secured.
 - 3. Ending point unknown at this time.
 - 4. A site that can host up to 50 people requested by Chair.
 - 5. Event capped at 20 vehicles.
 - b. The RR Chair requested to have access to the Region Official FaceBook account.
 - 4. Time Trials Report
 - a. A recent event at Putnam Park August 30th & 31st had low turnout.
 - 1. Reasons given were conflict with SCCA Solo Nationals and Labor Day weekend.

- b. ProPass financials discussed. ProPass early season offer will likely cease going forward.
- c. Catering options discussed.
 - 1. Lunch provided at the TT events in the GLDiv has been an expectation and likely to lose attendance if canceled.

C. Old Business

- 1. Chuck H. stated that Bruce F, leader of the Bylaw Revision Committee, has bylaw draft changes and is assembling a combined draft for Board review next month.
- 2. Year End Trophies discussed.
 - a. Program Chairs will handle procurement of their own trophies. Apparel discussed as other options exist like helmet bags, racing gloves, etc.
 - Some discussion of vendors and coordination between the Chairs to obtain volume discounts was discussed.

D. New Business

- 1. Police Co-operation event discussed with Mike Herrera.
 - a. Possibilities of charity events discussed as the program has had a similar successful event many years ago. Limit of one event per region per year.
- 2. Possibility of a 2026 Season Bunker Hill Dragstrip event during or after a Grissom Solo Event was discussed
 - a. Dragstrip operator has open dates from early September through seasonal close of the site.
 - Dragstrip would require for separate fees & tech inspection. Cost to likely be \$10 to \$15 per car.
- 3. Social media posts discussed.
 - a. Appropriate material in the context of promoting events discussed.
 - b. Request for a royalty free song selected for facilitating branding alongside posted videos.

A. Elected Director Reports:

- 1. RE Report:
 - a. RE Tashiro offer the minutes of the September 9, 2025 Board Meeting for review and were approved unanimously.
 - b. RE Tashiro then reported on the recent Solo event at Columbus.
- 2. ARE Report:
 - a. ARE Daubenspeck reported that the final sponsorship payment from Vitour Tires is due, this being the one-half (1/2) due at the season's end.
 - b. He also reported that a new editor for "Clutch Chatter" is needed if the ARE is elected to Treasurer. Keith advised he probably will not return as an Appointed Director in 2026, but could serve as Social Media manager in 2026.
 - c. The ARE noted the passing of member Will Zobbe and asked the Board whether to include an "in memoriam" page to Clutch Chatter. There was a brief discussion, and the consensus was for the inclusion. It was further agreed that obituaries would be okay to place in the newsletter, but the Editor was not responsible for seeking them. Members would have to send him the information to be placed in the newsletter.
- 3. Treasurer's Report:
 - a. The Treasurer was not in attendance.
 - b. Question was asked as to any outstanding amount of reimbursement owing to Program Manager. The Road Rally Chair noted that she was still awaiting reimbursement.
 - c. The RE is to be authorized remote account viewing access to the corporation bank accounts, but not writing checks debiting the region accounts.

4. Secretary's Report:

- a. Secretary Bartlett advised that he has a meeting scheduled with John Clyne to review more financial documents involved in the corporation's informal/internal audit. When this meeting has occurred, the third and final response to the AE's CID will be submitted.
- 5. Membership:
 - a. RE Tashiro reported for membership. He advised membership stands at 533.
- 6. Activities Report:
 - a. The Chair reported that he has a new phone number.
 - b. It was reported that the car show at Lincoln Tech was negatively affected by the weather. The RE suggested that Lincoln Tech could in the future hold such events indoors at their facility.
 - c. The ARE asked about status of year end awards for the January annual meeting and awards banquet. Points and awards are on the website.
 - d. Program Chairs are responsible for procuring year end awards for their program, but cooperation between the programs was encouraged for economization.

B. Appointed Director Reports:

- 1. Solo report was given by Chuck Neinhouse.
 - a. He advised concerning the number of drivers, weekend members and gross and net revenue for the program. He noted the program had a year end surplus.
 - b. Schedule conflict screening for 2026 is underway. He commented that the people at Grissom and the fairgrounds are good to work with.
 - c. The Chairman would like to step up the driving schools in 2026. He believes the demand would restrain higher fees. There was a total of 27 students this year. More teachers are needed.
 - Spring training for the Great Lakes Division will be in March, 2026. Chuck Neinhouse plans to attend.
 - e. The Solo bus cleaning event was proposed for the first Saturday in November. It was then noted that it was scheduled to be used at RallyCross #2 that weekend, so the cleaning event would have to occur some other time.

2. Road Rally Report:

a. Wendy Harrison reported the next event will be held on October 25. Four cars are registered at present. Event to start at Cloverdale and end in Greencastle at Monical's Pizza. Promotion was discussed.

3. Rally Cross Report:

a. An event is scheduled for November 9, 2025. If no more than 15 are signed up by November 5, the event will be canceled.

4. Time Trials Report:

a. The RE reported that 6 or 7 events are planned in 2026 for the Indy Region TT Series, but Indy would only host 3 or 4 of the events (Putnam and Gingerman). There was no report on program budget.

C. Old Business:

- The by-laws review is continuing. The ad hoc committee is planning a get-together meeting before
 the November Board meeting and hopes to have a recommendation to the Board at the next Board
 meeting.
- 2. Specific year end award responsibilities are:
 - a. Charles Tashiro:
 - 1. Fairbanks Memorial Competitor of the Year Award
 - 2. Worker of the Year
 - 3. McGee Member of the Year
 - b. Chuck Nienhouse
 - 1. Solo Competitor of the Year (Jack Tovey Cup)
 - 2. Spirit of Solo Award
- 3. The website has details with respect to each award. Trophies should be recieved by December 30 to be handed out at the awards banquet.

D. New Business:

- 1. Chris Wheatley was introduced as the election chairman for 2026 elections.
 - The ARE will send out e-mail solicitations for officers and elected Board seats. Chris Wheatley will draft an e-mail and send out regarding the election.
 - b. The newsletter will include election information. Rules for ballot uses were reviewed.
- 2. There was a brief discussion about using the Dallara Facility for the annual banquet. It was mentioned the banquet has been held there in the past.
- 3. Unless determined otherwise by the new Board, monthly Board meetings will continue at McAllisters.

There being no other new business or new motions, upon motion, second and discussion, the meeting was adjourned by a majority vote at 2000.

I plan to schedule 6 RallyCross events for the Indianapolis Region in 2026, and promote / post them well in advance. Thanks to all



I want to give a big thanks to our Solo volunteers that worked hard all year to make our events as smooth and safe as possible! Michael James and Chris Carson held down morning check-in (and last-minute registrations!), David Meyer managed the scoring and related technology, Darren Daubenspeck took care of worker assignments and was our go-to Safety Steward, Keith Hagen setup all of our MSR online Solo event registration, and David Currey stayed on top of our equipment bus maintenance and tirelessly worked the Tech Lane. David also volunteers to drive the Indy Region bus to all of our events!

Anyone who would like to volunteer next season is welcome to throw their hat in the ring. Please contact me over the winter to get on the list. One of the important positions for 2026 will be Course Designer. Several course designers would be ideal to bring variety to our events and to lighten the workload for all. Also, you don't necessarily need to be very experienced. As an SCCA approved course designer I plan on hosting course design training over the winter with the goal of getting people comfortable with course design and establishing a library of course ideas before the season starts. Notes from the Director's Chair Area 4 Director Update for November 2025

The past month has been a bit of a whirlwind. A trip to the Runoffs, lots of Zoom meetings before and after the event, and more prepping for my departure from the BoD filled my calendar.

As my tenure draws to a close, I thought I would explain how my replacement would be selected. Here's the process: I have one year left in my tenure as Area 4 Director. I will resign effective 12/31/2025. My replacement will be selected by the remaining BoD members. I have divorced myself from this, so I do not appear to sway the conversation or have the appearance of a conflict of interest. An announcement will be made in next month few weeks. The replacement Director will be able to attend the December BoD meeting for orientation and then serve out my second term, ending on 12/31/2026. They will be eligible to run for the office in 2026. Should they win that election, they will be able to run again in 2029. Further questions about all of this should be directed to Bob Crawford (bcrawford@scca.com) who is the Chair of the BoD.

Here's what I did since my last report.....

Video Conference Meetings:

• Electrified Vehicle Advisory Committee (EVAC) (10/8): The EVAC is working on a module on EVs for the online safety steward training available through the SCCA Academy. This meeting was a chance for the training subcommittee to reveal their efforts. It was a very good first stab at

the final product. We will review it over the next few weeks, polish it up a bit and send it to Chris Robbins and his squad for inclusion in the Solo and RallyCross Safety Steward training programs.

- Club Racing Board (CRB) (10/14): The group poured over the results from the Runoffs. Low car counts across all levels of the program dictate that we make some changes in the program. We needed to be more inclusive. Eric Prill came to us with a few ideas. We discussed those ideas at length. We would include F6, FF, and FV in the Hoosier Super Tour (HST) lineup again. We would suspend the performance criteria for 2026 Runoffs eligibility. The results of all of the CRB rules changes can be seen at this site: (https://www.scca.com/pages/cars-and-rules)
- CRB (10/22): This meeting was dedicated to discussing HST and Runoffs eligible classes. Some hard decisions were made and details of these conversations will be released on 11/13.
- Board of Directors (BoD) (10/27): Our financial outlook is getting better but we still were waiting for final Runoffs numbers. We reviewed the changes made in the Club Racing program. We got an update on the changes to the SCCA Foundation. We need to make it a stronger fund-raising arm for the Club. We also had the monthly series of program board liaison reports. We also had an executive session (no recording) on several members who behaved badly.

SCCA Events:

SCCA National Championship Runoffs at Road America (9/29 – 10/5): As CRB Chair, I knew that I needed to understand how impound works. I couldn't very well say "I dunno" if I was asked by a driver about how impound worked. As a racer, I had been to several Runoffs and knew about impound after a qualifying session. But I was never good enough to finish in the top six and warrant going to impound after the race. I was granted access during the week so I could get my eyes on it.

I arrived late in the afternoon on Monday, got registered and proceeded to the Tech Building to drop off some gear and meet the troops. I would return on Tuesday morning for the daily 7:15 meeting. As Tuesday and Wednesday were test days, we would have very little action except to do a few annuals and do driver optional weighings for cars after sessions. The real fun would start on Thursday and Friday as they were qualifying days. The Tech crew had spent all year working on a plan for how each class would be handled at the Runoffs. Each category and class had special requirements. Some classes would need specific parameters checked as they were limited (camber, restrictor size, etc.). The spec classes (SM, SRF3, etc.) would get viewed with a fine lens. It was all about making sure the vehicles were complaint for the race.

The stewards were omnipresent. If there was a violation, they would dispense penalties based on the level of offense.....some were let off with a warning. Others would receive much harsher consequences. As my main thrust was to learn about how the systems worked, I would need to keep an eye on all facets of the operation. I would listen in on conversations with drivers, scrutineers, stewards and staff. All had a hand in how the sausage was made.

Saturday would be my first race day within the inner sanctum. The top six cars would be impounded and the top three would be brought into the building. The others would be corralled outside and have some routine examination (weight, fuel test, etc.). Like qualifying, the class involved would dictate what parameters would be measured on the top three. It was all very exciting. Team members would start tearing the cars apart under the watchful eye of the scrutineering team. I wasn't witness to any discovery of shenanigans, but that cloud always looms. The good news is the team is prepared for it.

Sunday I decided to take a day off and watch some races. I'd seen what I needed to in Tech and really wanted to relax for a change. As you might imagine, when you wear a lot of hats, you get pulled into a wide variety of conversations. During the week there were many scheduled meetings and many more impromptu chats with BoD colleagues, drivers, stewards, CRB members, staff, etc. It made for a long week. Sunday would be a guiet day to watch races and hang out with friends.

As for those races, the competition was amazing. We had several races that were decided by less than a car length (side by side at the stripe). I encourage everyone to watch the videos on YouTube.

As usual, I had a great time at the event. The club has allowed me to become friends with folks from all across the country and this event is the time to have a chance to see them and catch up. I am always amazed how a bunch of volunteers can pull off such a monumental event. If you haven't been to this spectacle before or it's been a few years, I strongly urge you to attend next year. The Runoffs will be back at Road America (9/28-10/4) so make you plans now. Whether it's as spectator, volunteer worker, or driver, you'll enjoy the experience and be able to share it with old and new friends alike.

Be sure and visit the GLDiv website for information about all of the SCCA programs within the division. We have schedules, official's contact info, standings, etc. for all the SCCA programs.

Please take a few minutes and make sure your contact information is accurate in the SCCA database. It's important to have the correct information there so the club knows how to contact you. Log in to your my.scca.com page and check.

There is a new path to getting your annual waiver. You can now get it through the Member Account Portal (MAP). I've done it and it only takes a couple of minutes. Be prepared to upload a headshot picture of yourself.
