There will be a supply of pre-printed blank ballots available at the banquet for on-site completion. YOU MUST KNOW YOUR MEMBER NUMBER & WRITE IT ON THE BALLOT, ELSE IT WILL BE INVALID.

The Ballot in this issue of the newsletter should be considered preliminary. Per the bylaws, December 30, 2025, is the deadline for potential candidates to request to be considered for an Elected Director position.

If additional Elected Director candidates step forward before December 30, this ballot will be revised and emailed out to all members. A revised ballot will also be posted on the region Facebook page.

MINUTES OF THE MONTHLY MEETING OF THE
BOARD OF DIRECTORS OF SCCA INDIANAPOLIS REGION, INC.
HELD TUESDAY, NOVEMBER 11, 2025
AT RESERVED GUEST ROOM, McAllister's DELI
5822 CRAWFORDVILLE ROAD, INDIANAPOLIS, INDIANA

A quorum being present, the Assistant Regional Executive (ARE), Darren Daubenspeck, called the meeting to order at 18:30 in the absence of the Regional Executive (RE). Proxy votes were assigned by Charles Tashiro to Darren Daubenspeck and by Bruce Faucet to Chuck Hanson.

A. Elected Director Reports:

1. RE Report:

a. the ARE having called the meeting to order, advised that he would conduct the meeting in the absence of the RE.

b. The minutes of the October 12, 2025 Board Meeting were reviewed and unanimously approved.

c. The ARE noted for the record that the club is in its 80th year, and that he would like to see a new modified logo for the club reflecting the occasion, as the club had a special logo for the 60th and 75th anniversary years. He passed around an image of the logo from 2006. He said that there is a need for someone to sketch a new logo for promotional use. It was mentioned that the webmaster John Wilmoth did the 60th year logo.

d. The ARE reported that the timing system equipment had been removed from the Solo Bus, and their batteries removed. The equipment is in Dave Currey's basement for winter storage.

e. The ARE reported also that the October/November Clutch Chatter will be a double issue, and that November 14 was the cutoff for publication items.

f. The ARE suggested that the club explore a continued sponsorship with Vitour for 2026.

2. ARE Report (combined with RE Report above).

3. Treasurer's Report:

a. The Treasurer was not present. The ARE confirmed that the RE has remote access to all club accounts. All corporation funds are in the checking and money market savings accounts, and noted the current balances sent from the RE.

b. The ARE announced to the Board that recommendations for the office of Treasurer are needed for the upcoming election.

c. The ARE reported that the corporation is current with all obligations to the national SCCA.

4. Secretary's Report:

a. Secretary Bartlett reported that following his meeting with former Treasurer, John Clyne, he would be finalizing the third and final response to the Attorney General's C.I.D.

5. Membership:

a. The Membership Chairman reported that the club has five new members, six weekend members and seven membership expirations leaving membership at present 529.

b. The ARE inquired about using the World of Wheels car show to recruit new members. The chairman observed that typically shows involved a lot of money, but not much reward, and preferred recruitment at the IMSA event. The ARE stated a space at IMSA was about 10x the cost of the World of Wheels space. Chris Carson suggested that the club do more with Cars and Coffee type events. Mickie Miller suggested displaying video of our activities at such events.

c. Lee Miller inquired about updates for Involved Member jackets. It was pointed out that information is available on the website for involved members. Dustin Hitze said he would bring a form for jacket eligibility to the next board meeting.

6. Activities:

a. Via phone, Ethan Decatur confirmed his is arranging the schedule for the banquet to be held Saturday, January 17. He also reported that the first payment to the venue of \$3,100.00 had been made, but a second payment in an equal amount is due.

b. The ARE inquired about the program awards for the banquet. He said there did not seem to be progress with respect to the trophies. He recommended that the award banquet would not be "the RE show", and that program chairs would be expected to present trophies and awards as has been traditionally done in the past years.

c. The ARE asked for a status report on the Winter Karting League. Chuck Neinhause reported that the Winter Karting program was underway and that Justin Ritter is managing the program under Ethan Decatur's Activities program.

d. Details of the 2026 Election were discussed with respect to the banquet. Election timing in the current bylaws was discussed. It was recommended that in person ballots would be accepted until 18:00 the evening of the event with a 20 minutes cutoff notice preceding. Mailed ballots must be postmarked with the Friday before the banquet.

B. Appointed Directors' Reports:

1. Solo Report was given by Chuck Neinhause.

a. The chairman reviewed the program's cash flow for the 2025 season, and it was positive.

b. The chairman noted his progress on 2025 year end award procurement.

c. It was discussed that some participants at the Points #7 Solo event at Grissom thought the course was too "tight" for the site, and was negatively received. The next day Points #8 course was more "open" and fast, like a normal Grissom course, and was more popular with the drivers. The comments were noted in the interest of future events.

2. Road Rally Report was given by Wendy Harrison.

a. She handed out a summary of the year's events and reported net revenue for the year. She announced that current Road Rally Championship standings are available.

b. She also said that participants brought pets to the October RoadRally and the restaurant let her know that was not acceptable. In the future she will make sure she mentions on the event announcements that we will be dining in the restaurant at the end of the RoadRally.

3. Rally Cross (RX) Report was given by Mike Herrera.

a. He reported the November 9 Badlands RX event was canceled due to not achieving the required number of entrants, and the site conditions were too wet and sloppy for a safe event.

b. He said the national office is considering a national event in 2026 at the Badlands.

c. Six events are proposed for 2026. He reported he has backup staff help to step in as qualified substitutes to run the events.

d. The ARE commented that scheduling needs to be coordinated with the Solo Program to avoid conflicts, as they use the same equipment. The RX chair stated that the program could likely use INR region's equipment if there is a conflict with an Indy region Solo event.

e. The chair has an 80% proposed budget for 2026.

f. The RX chair requested assistance to develop the points & awards rules for the RX program. It was suggested to use the existing rules on our website for both the Solo and Road Rally programs as a starting basis, but modify them for the different structure of RX scoring. A spreadsheet needs to be created for Rally Cross and a dedicated Rally Cross laptop is needed. David Meyer, Chuck Neinhause and the chair are to confer on issues.

C. Old Business:

1. The proposed update to the corporation by-laws was given by Chuck Hanson. There was a general discussion of the use of must, shall and may when applied to compulsory or discretionary phrases. The proposed modifications were outlined by Chuck and discussion ensued in each proposal with the Board generally in agreement with the work of the ad hoc committee, but multiple errors were discovered during the read-through.

2. The ARE noted that a phrase was needed to adopt the Standard Rules of Parliamentary Procedure, and the Secretary agreed to provide.

3. The ARE suggested that the Digital Section of the Secretary's duties be stricken from the by-laws because it would be an undue labor and cost burden to the region. It was discussed that the Board consider finding a volunteer to administrate online secure file storage for BoD member online access. An ad hoc committee of Chuck Neinhause, David Currey and Dustin Hitze volunteered to explore this option.

4. No vote was called for to approve the revised by-laws for the membership to vote upon for adoption or rejection at the annual meeting of the membership.

D. New business: None stated.

There being no other new business or new motions to consider, upon motion, second and discussion, the meeting was adjourned by a unanimous vote at 2000.

2026 Election: Region Elected Director Job Descriptions:

It's getting near that time of year when Regions are considering new elected director candidates for 2026. To recruit new leaders the following Job Descriptions for the 6 Region Elected Directors is presented. This list is by no means comprehensive, and is offered as a guide for the upcoming election, which will be final at the 2025 Annual Meeting and Awards Banquet, on January 17, 2026, at the Biltwell Event Center.

Our current Treasurer has notified the BOD that he cannot continue in this role for 2026, so that is one known open seat at this time. All positions are to be contested. Please email bod@indyscca.org and/or election@indyscca.org if you are interested in being a candidate for any of the 6 elected director positions.

Regional Executive

- Chief Executive Officer of the Region.
- Official Spokesperson for the Region.
- Presides at all meetings of Members and Directors.
- Shall report on the status of the Region at each meeting.
- Shall call any special meeting of Members and Directors in accordance with the Bylaws of the Region.
- Prepares and adheres to agendas for all meetings.
- With Board approval, shall sign and execute, together with the Treasurer (or his designee), all contracts, notes, and drafts in the name of the Region.
- With the Board, participate in creating the Region's budget for the coming year.
- Shall perform or cause to be performed all duties assigned to him/her by the Sports Car Club of America, Inc.
- Shall Coordinate with the Treasurer and Secretary to cause books, statements, reports and other certificates and records to be filed as required by law.
- Shall complete (with aid of Assistant RE) Region SCCA Charter Documents and submit to the National Office no later than February 15th of each year.
- Shall enforce Region's Bylaws and perform all duties incidental to the office of Regional Executive.
- Shall give guidance to all activities of the Region.
- Shall have other such duties and authorities as prescribed by Bylaws or Regions Board of Directors.
- Communicate as needed with Executive Officers of other local sports car clubs, SCCA Regions, and SCCA Divisions.
- Shall maintain communications with the responsible SCCA Area Director.

Assistant Regional Executive

- Performs duties of the Regional Executive in that person's absence or incapacity.
- Performs other such duties as assigned by the Regional Executive.
- Performs duties as assigned by the Region's Board of Directors.
- Shall attend all meetings of the Members and Directors.
- With the Regional Executive, shall prepare the Region's SCCA Charter Documents and submit to the National Office no later than February 15th of each year.

Secretary

- Shall keep minutes of meetings of Members and Directors.
- Shall be the custodian of all records of the Region.
- Shall attend all meetings of the Members and Directors.
- Shall maintain the Region's calendar of events.
- Shall submit the Region's calendar to newsletter and website

Treasurer

- A. Shall have care and custody of, and be responsible for all funds, merchandise, and assets of the Region.
- B. Shall have custody of monies, debts, and financial obligations of the Region.
- C. Shall attend all meetings of the Members and Directors.
- D. Reports financial status of Region to Members and Directors.
- E. Shall maintain accounting records in accordance with Generally Accepted Accounting Principles.

- F. Pays any listing or sanctioning fees in advance of any SCCA event.
- G. Pays invoices submitted to the region by outside vendors, Program Directors, or others.
- H. Shall transmit dues and income information received from the SCCA National office to the Region's Membership Chairperson.
- I. Shall make monthly, or more often if required, deposits to the Region's bank account.
- J. Obtain tax exemption certificate if required.
- K. With the Regional Executive, participate in creating and assist to determine the Region's budget for the coming year.
- L. Shall ensure preparation and filing of tax returns in accordance with the Internal Revenue Code of the United States and other controlling jurisdictions.
- M.** Shall notify the Region's bank(s) when changes are made with respect to addresses, signatures, and other contact information for new officers or check signers.

Membership Chairperson

- The Membership Chairperson promotes continued growth of the Region through actively recruiting new members and retaining current Members.
- Shall be the Chairperson of the Membership Committee.
- Shall make new Members and other interested parties feel welcome at all Region events.
- Shall manage the Involved Members recognition program.

Activities Chairperson

- Manage all details of the January Annual meeting with guidance from the Board of Directors.
- Collaborate with other SCCA region officers and chairpersons (e.g., Solo Chairman, Rally Chairperson) to ensure a cohesive and well-rounded regional calendar.
- Communicate event details and information to the membership through newsletters, websites, social media, and other channels.
- Coordinate with the Membership Chairperson to promote membership growth and engagement by developing outreach initiatives and creating a welcoming environment for new and potential members at events.
- Work with the Regional Executive and Board of Directors to ensure activities align with the region's goals and the overall mission and vision of the Indianapolis Region SCCA

Other Appointed Directors

- D. Shall attend all meetings of the Members and Directors.
- E. Shall perform such duties and have such powers as assigned by the Board of Directors
- F. May be assigned as liaison to committees and specialty program managers who are not already members of the Region's Board of Directors.
- G. May be the Program Manager of one of the Region's Programs
 - 1. Is strongly encouraged to develop and empower a team of members to administrate the Program's Events
 - 2. Must develop an event schedule
 - 3. Must create a yearly Program Budget Proposal for review and approval by the Board of Directors
 - 4. Must manage all aspects of the Program and its events.

Having been a few times, I learned to zero in on what is new, different, and aligned with my needs as an SCCA member. This year I was able to talk with a Bosch engineer about the cool technology in the Corvette GT3 car Robert Wickens' has been driving.

Another task at PRI was to check out new helmets since my old Bell was aging out. If you haven't heard, the SCCA is going to require SNELL 2015 and later certified helmets starting in 2027. Fortunately, we have a bit of a reprieve in SOLO next year and SNELL 2010 helmets will still be allowed for the 2026 season. While looking around for a new lid I ended up learning quite a bit. For one, the SCCA will also accept helmets certified by the FIA and SFI.

Yeah, this is a bit more complex than I first thought! It might be best to print out that page! Here's some explanation - the prefix letters mean different things as follows:

SA = "special application" for automobiles

EA = "elite application" for use with HANS devices, coolers, aligns with FIA 8860

K = karting


M = motorcycles

The suffix letters on the motorcycle SNELL certification are "D" for DOT and "R" for EU regulations. None of these details really apply to SOLO because all of the listed helmet certifications will be accepted at 2026 Autocross and Rallycross events. However, for 2027 events the 2010 certifications will NOT be allowed.
