
2025 Season Awards Banquet Report and Pictures:

The region held its annual meeting of the members and season awards banquet on Saturday, January 17th, at the Biltwell Event Center in downtown Indianapolis. This year, in addition to the normal dinner and awards ceremony, a referendum on changes to the bylaws was held. The referendum was passed, so please look for the updated bylaws to be dated January 2026 on the region website soon.

Winners of the 2025 season programs year-end championships were posted in the October - November 2025 newsletter and website, and won't be re-posted in this issue.

The region financial report was given by the Assistant RE, and was based on records of December bank account totals looking back for 4 years. Over the years 2021 to 2024, the region's account decreased by about \$30,000. But, a comparison of December 2024 to December 2025 bank account totals showed the region gained a \$13,000 surplus, a reverse of the downward trend of past years. This is a positive indication for the direction of the region, in that we will survive into our 80th year. All programs except for Time Trials and Activities returned a surplus for the 2025 season.

On to the special awards: 2025 Involved Member jackets were awarded to Lee and Mickee Miller, and Jeff Alexander.

National Convention Award Winners from Indianapolis Region:

The National SCCA convention was again held virtually this year, spanning from January 15th to the 23rd. Hopefully you had time to participate in some sessions focusing on your specialty. Two Indy Region members were recognized this year at the convention.

Joel Harleman, current member and past Indy Region RE, won the **National Worker of the Year in Stewarding**.



"Joel's calm demeanor, sound judgment, and approachable nature set him apart," said Sydney Davis Yagel, SCCA's Manager of Road Racing Special Projects. "While others may spend years trying to master composure under pressure, our winner seems to have been born with it."

Joel went from SOC Chief to test day Operating Steward, to race day Operating Steward. His leadership and capability are also showcased during Hoosier Super Tours, where he serves as the East Coast Clerk of the Course, a position he's filled for several seasons with steady excellence.

"As the person who nominated him put it: 'At this stage, Joel is as well-rounded as they come – yet those of us who've worked alongside him know something special: the best is still yet to come,'" Yagel added.

2025 Kimberly Cup: The 2025 Kimberly Cup award goes to the 2025 B-Spec National Champion Eric Yagel of Houston and Indianapolis Regions.

Named after Jim Kimberly, former President and Governor of SCCA, the Kimberly Cup is awarded to the SCCA driver showing the most improvement in the last year, as selected by the Club Racing Board. Recipients include notables such as Mark Donohue, Roger Penske, Richard and Keith Grant, Amy Aquilante, Steve Introne, and last year's recipient, Tyler Ladd.

"This year's recipient had a true racing community upbringing," said Eric Prill. "Starting off as a mechanic for a Houston-area based prep shop, our driver wrenched on Spec Miatas until he could change transmissions in his sleep. His first opportunity to drive wheel-to-wheel came in the fall of 2011 as payment for changing a head gasket at an endurance race, and it was quickly evident that he was a natural."

He soon obtained his SCCA Competition License and proceeded to race any and every car he was given access to. That journey eventually led him to B-Spec, although getting behind that wheel was hardly a direct route.

"He may have come for the cars, but he stayed involved for the people," Prill added. "And when one relationship at the track spilled over into his personal life, it led to a marriage proposal at the annual Houston Region banquet in 2015. Marrying into a racing family had its perks, too. It came with access to a membership racetrack, a racecar, and no need to ask your spouse for permission to go race."

Election Chairperson Report: Chris Wheatley

Voting for the election of the Region's Board of Directors for 2026 concluded at the annual banquet on January 17. The election process began with a call for candidates, along with descriptions of the responsibilities for each of the six elected director positions, published in the October–November edition of Clutch Chatter.



Also included on this year's ballot was a vote to approve or reject proposed revisions to the Region's Bylaws. The December edition of Clutch Chatter published the preliminary ballot and outlined the election process and key dates.

Following the receipt of nominations for all positions, the final slate of candidates was posted on the Region's website and Facebook page, distributed via email, and made available in printed form at the annual banquet. Members were able to submit completed ballots by mail, email, or in person at the banquet.

I am pleased to report that the election resulted in the following directors being elected, each receiving 34 votes:

A quorum being present, the Regional Executive (RE), Charles Tashiro, called the meeting to order at 1832 in the reserved guest room of McAllister's Deli located at 5822 Crawfordsville Road, Indianapolis, Indiana.

A. Elected Director Reports:

- 1. RE Report:**
 - a. The RE presented the minutes of the November 11, 2025 Board meeting which were reviewed and unanimously approved.
 - b. The RE stated he will give the Treasurer's Report at the annual meeting. Ethan Decatur volunteered to be the master of ceremony for the event.
- 2. ARE Report:**
 - a. After meeting close, the ARE requested attention and advised of a deadline for December newsletter submissions.
 - b. Dates for the publishing of the Election Ballot in the newsletter, via email, and online were discussed.
- 3. Treasurer's Report:**
 - a. Bank account balances from November 2024 and November 2025 were shared with the Board, showing an increase over the 12-month period, indicating that the club had positive cash flow for the year.
- 4. Secretary's Report:**
 - a. Secretary Bartlett reported he will be submitting final response to the Attorney General's C.I.D. soon.
- 5. Membership:**
 - a. Motion made to allow a budget for the Chair to fund either new jackets or updated embroidery for the involved Members who submitted their 2025 activity forms. Motion was seconded, no objections, vote to approve was unanimous.
 - b. Total membership at present is 525.
- 6. Activities:**
 - a. The upcoming banquet was discussed. The chair advised he would create a schedule of events and speakers for the banquet.
 - b. The RE stated that he wants the program chairs to present awards to their recipients at the banquet, and would like all Board members to say a few words at the banquet.
 - c. The ARE requested that all who would be presenting their awards to please be prepared with a printed list of names & awards for the presentation.
 - d. Season award procurement progress was discussed. The RE, Solo Chair, and Road Rally Chair discussed their progress in award procurement, indicating that all awards would be ready to be given to recipients at the banquet.

B. Appointed Directors' Reports:

1. Solo Report was given by Chuck Neinhause.

- a. The chairman stated he is working on the 2026 schedule. Seven Points events are already scheduled of a desired nine. Share events with other regions were discussed. The Solo Committee is to work out details with any shared events with Ft. Wayne NW.
- b. The question of the location of the annual traveling trophy for the Solo Competitor of the Year (The Jack Tovey Cup) arose, inquiring if it had been returned by the previous recipient to be prepared and engraved for the 2025 award recipient. The answer was negative. The ARE volunteered to retrieve the Tovey Cup. The RE then responded that he would retrieve the Tovey Cup trophy, the Fairbanks trophy, and the McGee trophy, have the engraving updated on all of them, and have them ready for the awards banquet. The ARE acquiesced to the RE for this task.

2. Road Rally Report was given by Wendy Harrison.
 - a. Competitor of the Year (Fairbanks trophy) results were discussed, and a winner was declared. Wendy has budgets for all events available.
3. Rally Cross (RX) Report was given by Ethan Decatur for Mike Herrara.
 - a. Potential 2026 RX schedule is in progress.
 - b. He reports details of a Vitour party during PRI to be held in downtown Indianapolis.
4. Time Trials:
 - a. Charles Tashiro reported an event is scheduled in the Kentucky Region at the National Corvette Museum in Bowling Green, May 18, 2026. He announced there would be no event at Mid-Ohio in 2026.

C. Old Business:

1. 2026 Election Chair report:
 - a. No new candidates have requested to be stated on the ballot.
 - b. Per current bylaws, the ballot would be locked on December 30, 2025.
 - c. It was decided to release the current ballot around December 15, and if any candidates presented between 12/15 and 12/30, the ballot would be revised and reissued. Any votes sent between those dates could be revised by the voter.
2. Bylaw revision discussion. Errors were found, and some issues unresolved. It was decided to hold a special BOD meeting to discuss bylaw revisions next Tuesday on December 16th.
3. The Ad Hoc committee for online secure file storage for BoD business was discussed. The committee recommendation was to create a google drive folder / location for this purpose, but no owner / administrator / admin volunteered to create such drive, and future administration of this electronic file storage location was unclear.

D. New business:

1. Chuck Smith expressed a desire to hold a Tech Day in the spring. Past Tech Day/Spring Training events were discussed. This proposed event would primarily be for Club Racers to bring their race cars for the yearly tech inspection. A location would have to be found, and a date was not scheduled. Chuck Smith was authorized to make arrangements for the day, but no budget was proposed or authorized.
2. Ballot details were discussed and ballots for the election will be published on December 30. Ballots will be available at the annual meeting on Saturday, January 17, 2026. Email and hard copy ballots are to be submitted prior to 6:00 p.m. on January 17, 2026. A person must be an "official" member on December 31, 2025, to vote.
3. Further discussion of by-laws changes followed facilitated by Chuck Hanson. A special meeting is to be called for December 16 to finalize by-law changes to be recommended to the membership at the annual meeting.
4. There was discussion as to how to preserve corporate documents for secure Board member access. An ad hoc committee is to explore and report.
5. The 80th anniversary of the region in 2026 was discussed.
 - a. Modified Indy Region logos provided by John Wilmoth were discussed, and the oak laurel design was approved via unanimous vote.
 - b. A celebratory event for the 80th anniversary was discussed as a desired event, but no date, location, or budget was proposed.

There being no other new business or new motions to consider, upon motion, second and discussion, the meeting was adjourned by a unanimous vote at 20:00.

A. Call to Order. A quorum being present, the Regional Executive (RE), Charles Tashiro, called the meeting to order at 1830 in the reserved guest room of McAllister's Deli located at 5822 Crawfordsville Road, Indianapolis, Indiana.

B. This being a Special Meeting, there were no minutes to review.

C. Officer Reports:

1. RE

- a. The RE announced the sole item on the agenda was the proposed changes to the Corporate By-laws to be submitted to the membership at the annual meeting of members on Saturday, January 17, 2026, and that no other business could be conducted.
- b. He asked for a show of hand by those who had read the proposed changes discussed at prior meetings which had been e-mailed to the Board following the regular Board meeting held on December 9, 2025.
- c. There were no other officer reports as all attention was focused upon achieving a final version of recommended changes to the By-laws.

D. Discussion of By-law changes:

1. Chuck Hanson acted as facilitator for discussion of recommended By-law changes.
 - a. An abbreviated summary of recommended changes is as follows:

Article II :Sec. 1	Lifetime members no longer pay dues. The meaning of "in good standing" was reviewed. The meaning of "suspension" and "removed" were clarified.
Article III :Sec. 3 Sec. 5 Sec. 7	The use of "must" and "shall" was clarified, Voting list definition was discussed, Use of Proxy clarified, Election procedures discussed, - "notices" and "ballot" distinguished, - election committee responsible for evaluation, of candidates and removal from ballot with respect to elected positions only

Article IV: -

- Board members are as enumerated in Section 6,
- RE votes only to break a tie,
- All elected and appointed directors must execute a policy acknowledgment for both conflict of interest and whistleblower policies,
- Removal of a board member requires 75% of the entire board,
- Proxy assignment of a board member may only be to another board member,
- Executive Committee meetings to require 3 for a quorum and shall consist only of elected directors,
- The board at its next regular meeting may ratify or rescind any Executive Committee action

Article XII: - (d) A new article to be added adopting the Standard Code of

Parliamentary Procedure 4th Edition as a reference to resolve any procedural issues not addressed by the Articles of Incorporation or By-laws.

A lengthy discussion followed regarding inclusive in the By-laws provisions with respect to creation of a system for more secure remote access of corporate documents available to board members. It was decided by consensus not to include such provisions in the By-laws at this time.

Bruce Faucett moved for approval of the final version of the By-laws to be recommended to the membership. The motion was seconded by Charles Tashiro and passed unanimously following discussion.

The summary of changes and the full text of the recommended text of the By-laws is to be attached to the minutes for the corporate book.

With no further business to be conducted, the meeting was adjourned at 2006.
